National Forensic Sciences University had the rare honour to host the Chief of the Army Staff. On 13th April 2022, General M.M. Naravane PVSM AVSM SM VSM ADC, the then Chief of the Army Staff, became the first Service Chief to visit the university. The General arrived at an appointed time of 10.00 A.M. and he was warmly received by the Hon'ble Vice Chancellor, Dr. J.M. Vyas. The Army Chief was accompanied by Army Commander of the Shimla based Army Training Command (ARTRAC), Lt Gen S.S. Mahal AVSM VSM, who arrived just before the General. Hon'ble Vice Chancellor thereafter introduced the Army Chief with Campus Director of NFSU's Gujarat Campus, Prof. (Dr.) S.O. Junare; Executive Registrar of NFSU, Shri C.D. Jadeja; and Chief Coordinator of the visit and Dean, School of Police Science and Security Studies, Air Commodore K.R. Thaakar. Soon on arrival, an introductory meeting was held in the office of the Vice Chancellor which was attended by Gen Naravane, Lt Gen Mahal, Dr. Vyas and Air Commodore Thaakar.

The visit began with a detailed presentation on NFSU by Air Commodore Thaakar. It was also attended by accompanying senior Army officers, Major General (now Lt Gen) Vivek Kashyap AVSM VSM, Major General Vikrant Naik VSM and Major General Bikramdeep Singh VSM. Other NFSU team members who participated in the briefing were Campus Director of Delhi Campus, Dr. S.K. Shukla; Dean of School of Cyber Security & Digital Forensics, Prof. (Dr.) Naveen Kumar Chaudhary; Dean of School of Law, Forensic Justice & Policy Studies, Prof. (Dr.) Purvi Pokhariyal; Joint Registrar of Delhi Campus, Air Commodore R.N. Gaekwad; and Head, Centre for Futuristic Defence Studies, Group Captain Ajay Purandare. Hon'ble Vice Chancellor highlighted the training imparted to the Service personnel. Thereafter, Dr. Vyas suggested the courses that could be offered and various short term training courses that could be organised for the Army officers. He laid special emphasis on the various technologies and projects that could be beneficial to the Army for varied purposes, and offered to













collaborate. In this regard, Group Captain Purandare briefed in detail about the different defence related areas. At the end of it, Hon'ble Vice Chancellor and the Army Chief exchanged the mementos.

After the presentation, Gen Naravane and his team visited the Centre for Futuristic Defence Studies where Group Captain Purandare showcased the varied defence related projects especially the ones with possible applications for the Army. This was followed by a visit to the Cyber Defence Centre where Dr. Chaudhary briefed about the recent upgradations. In particular, the Army Chief was impressed with the Cyber Kiosk that scans the mobile devices and not only detects the malware but could also remove it. The next visit was to the Forensic Psychology Laboratory where the team witnessed different systems being employed for criminal investigation. Dr. Vyas explained the possible uses of these systems for the Army such as for mass scanning for access control, investigation of intruders feigning as mentally deranged, recruitment, etc. Thereafter, the Army Chief visited the Ballistics Research Centre and Testing Range where he was apprised about the different types of testing being undertaken especially the bullet-proof materials being used for jackets, helmets, vehicles, tyres, glass, etc. The last stoppage was a High Tea with the senior faculty members and the staff where the General briefly interacted with them.

As the visit came to an end, Gen Naravane, Lt Gen Mahal and other senior officers of the entourage were seen off by the Hon'ble Vice Chancellor, Dr. J.M. Vyas, accompanied by Dr. Junare, Shri Jadeja and Air Commodore Thaakar. The Army Chief went back, carrying with him number of ideas for collaboration with NFSU.

#### PRESIDENT OF INDIA PRESENTS 'PADMA SHRI' AWARD TO DR. J.M. VYAS







In a glittering but dignified investiture ceremony held at the magnificent Darbar Hall of the Rashtrapati Bhavan on 21st March 2022, Hon'ble President of India, Shri Ram Nath Kovind conferred one of the country's highest civilian awards, 'Padma Shri' to the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas. This was in recognition of his lifelong distinguished service to the nation in the field of forensics investigation and training. As is well known, besides being the founder Vice Chancellor of NFSU, Dr. Vyas is a veteran forensic scientist with vast experience of 48 years, making him the senior-most Forensic Scientist of the country. Some of the high points of a shining career spread across five decades are serving Gujarat's Directorate of Forensic Science since 1973, heading it from 1993 - now as its Director General, successfully undertaking innumerable scientific investigations of high profile heinous crimes of the country, becoming pioneer in the vital area of professional forensic education, translating the vision of the Hon'ble Prime Minister, Shri Narendra Modi, to establish the world's first forensics university, its upgradation to be the National University, its recognition as an 'Institution of National Importance' (INI) by the Government of India, embarking upon major expansion to launch campuses from scratch in other states and abroad, etc.

While the Padma Awards are announced on the occasion of the Republic Day, they are conferred by the President of India subsequently on two separate ceremonial functions at the Rashtrapati Bhavan. The Awards are conferred in various disciplines such as art, social work, public affairs, science and engineering, trade and industry, medicine, literature and education, sports, civil service, etc. This year, a total of 128 Padma Awards were conferred. In this Civil Investiture Ceremony-I held at Rashtrapati Bhavan on 21st march 2022, besides Dr. J.M. Vyas, President Ram Nath Kovind presented Padma awards to former Chief of Defence Services, General Bipin Rawat (posthumously), Chairman of the famous Gita Press at Gorakhpur, Radhey Shyam Khemka (posthumously), veteran leader Ghulam Nabi Azad, Tata Sons Chairman N. Chandrasekharan, M.D. of the Serum Institute of India Cyrus Poonawalla, welfare activist Swami Sachchidanandji and 125-year-old yoga enthusiast of Varanasi Swami Sivanand. Hon'ble Vice President Shri M. Venkaiah Naidu, Hon'ble Prime Minister Shri Narendra Modi, and Hon'ble Home Minister Shri Amit Shah were amongst the several dignitaries were present. Eleven senior women forensic scientists from all over the country, were felicitated by Dr. Nimaben Acharya, Hon'ble Speaker of the Gujarat Legislative Assembly as part of the celebration of International Women's Day on 15th March, 2022 at NFSU, Gandhinagar. Welcome speech was delivered by Prof. (Dr.) Purvi Pokhriyal, Dean-School of Law, Forensic Justice and Policy Studies. Dr. J.M. # INTERNATIONAL CONFERENCE ON LAW & FORENSIC JUSTICE IN COLLABORATION WITH ICSSR







On 5th-6th March, 2022, the School of Law, Forensic Justice and Policy Studies (SLFJPS) of NFSU organised an International Conference on "Law & Forensic Justice" in collaboration with the Indian Council of Social Science Research. The conference aimed to provide a premier interdisciplinary platform to discuss the most recent innovations, trends and concerns in delivering justice and highlight the practical challenges encountered and the solutions adopted. The inaugural session was graced by many esteemed national and international dignitaries such as Professor Emeritus of NFSU, Dr. Henry C. Lee, Founder-Director of the Henry C. Lee Institute of Forensic Science at the University of New Haven, Connecticut; Prof. (Dr.) Stephen Barnes of Penn State Law; Judge Mel Flanagan, Former Circuit Judge from Sarajevo, Bosnia; Dr. G.K. Goswami, Additional Director-General of Police & Anti-Terrorist Squad, State of Uttar Pradesh; and Justice Abhilasha Kumari, Judicial Member, Lokpal Committee of India and former Chief Justice of the Manipur High Court who was the Chief Guest of this event. At the outset, Prof. (Dr.) Purvi Pokhariyal, Dean, SLFJPS welcomed the distinguished guests and all the participants to the conference. After that, Prof. (Dr.) Purvi Pokhariyal, Prof. (Dr.) Navin Chaudhary (Dean, School of Cyber Security and Digital Forensics), Air Commodore K.R. Thaakar (Dean, School of Police Science and Security Studies) and Dr. Navtika Singh Nautiyal (Asst Professor) welcomed the different guests with a bouquet of flowers and memento.

As a keynote speaker, Professor (Dr.) Henry C. Lee, discussed the importance of law and forensic justice in contemporary times; and how this can benefit the society. Another speaker, Prof. (Dr.) Stephen Barnes focused his talk on procedure of justice and how various social reformers such as Mahatma Gandhi, Martin Luther King Jr., and Rosa Parks emphasised on attaining justice through their acts and deeds. Judge Flanagan highlighted the blending of forensic science and law. Dr. Goswami discussed the darker sides of investigation and the need for identifying innocence. He also discussed the misconduct in legal procedures. The chief guest of the inaugural ceremony, Justice Abhilasha Kumari, laid emphasis on the significance of forensics, DNA mapping, and other aspects of Law and Forensics, in investigative procedures. The entire conference was divided into seven sessions where numerous researchers, practitioners and educators presented their views specifically aimed at exploring the versatility of forensic justice and law and held deliberations on the need of forensic science in the examination of evidence and its admissibility in the judicial system.

The first session was chaired by Mr. Mitesh Amin. The guest speaker, Mr. Yili Dautaj who spoke on the topic 'E-discovery and Forensic Evidence in International Arbitration'. The session had four presentations which were on interesting topics such as application of LIDAR, and use of insects for understanding post mortem intervals. The second session started with an introductory discussion on 'Racial profiling in Europe and the response by the EU and European Court of Human Rights' by the guest speaker, Prof. Adam Dubin. The chair of the session was Dr. Jyotsna Yagnik. The session also had three presenters who spoke on a wide range of topics of forensic science and its application in the legal system. The Session ended with the felicitation of the chair of the session by Dr. Nandita Chaube. The third session was chaired by Dr. Beulah Shekhar, Chair Professor (Proposed), LNJP Chair of Criminology. There were seven presentations in this session. The topics ranged from 'Neurological Evidence' and 'Examination of Cortex' to 'Challenges of Forensic Sciences' and 'Forensic Investigative Procedure'.

The fourth session was chaired by Dr. G.K. Goswami which started with the introductory discussion by the guest speaker Dr. Jill Callahan Engle, who talked about domestic violence, its different forms, and the tactics used in cyberspace. The presentations included interesting and informative topics such as acceptance of the BEOS system in court proceedings, discretion of using forensic evidence by court and the role of forensic science in access to justice. The fifth session was chaired by Dr.Archana Bahuguna, Scientist 'E', High Altitude Regional Centre, Zoological Survey of India. There were many presentations by vivacious participants ranging from 'Neuro Profiling of victimisation' to 'Suicidal hanging' and 'Wildlife Protection Covering'.

The sixth session was chaired by Justice Abhilasha Kumari. The guest speaker was Judge Ms. Mel Flanagan who primarily discussed juvenile violence, the vulnerability of children in the social and legal realms, and the problems of intergenerational violence which needs to be addressed adequately. The seventh and the last session of the conference was chaired by Dr. Rukmani Krishnamurty, Chairperson and CEO, Hemlock Advisory Ltd. The session had presentations on many captivating topics like 'Analysis of Inhalants', 'Development of Cyber Forensics', 'Expert Evidence', 'Credibility of Forensic Evidence' and 'Organised Crime'. Soon after the seventh session, the valedictory function was organized in which Dr. Rukmani Krishnamurthy graced the occasion as a chief Guest. She was welcomed and felicitated by Justice Abhilasha Kumari. The researchers and paper presenters were felicitated with certificate and memento by Dr. Rukmani Krishnamurthy and Justice Abhilasha Kumari. The session came to a conclusion with the felicitation of the chair by Dr. Navtika Nautiyal.



#### **ACTIVITIES**

#### **NFSU SECURITY COLLOQUIUM - PARTICIPATION BY INDUSTRY AND THINK TANKS**







The first-ever NFSU Security Colloquium was organized by the School of Police Science and Security Studies (SPSSS) of NFSU at its Gujarat Campus on 2nd-3rd March 2022. The main aim of the colloquium was to enhance the cooperation between the Industry fraternity and the Academia for synchronizing the demands of the industry with the skill sets and knowledge being imparted to the students. Towards that, the colloquium comprised signing of MoUs with major industries and security-oriented think-tanks, talks by eminent personalities, panel discussions between industry leaders and faculty members, and interaction between students and security heads of industries. The Colloquium was inaugurated by the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas, by traditional lighting of lamp along with the dignitaries on the dais. This included Shri Shekhar Dutt, SM, former Governor of Chhatisgarh, ex-Deputy National Security Advisor and ex-Defence Secretary; Air Marshal (Dr.) M Matheshwaran AVSM, VM (Retd.), Founder President of The Peninsula Foundation; Shri. Sanjeev Tripathi, IPS (Retd.), former Chief of RAW; Col Samrendra Mohan Kumar, Co-founder & MD, MitKat Advisory Services Pvt. Ltd; Col VS Chandrawat, SM, CPP, President Security, Adani Group; Smt. Neeru Abrol, former CMD of National Fertilizers Limited; and Shri Aditya Tikoo, Founder Convenor of Global Counter Terrorism Council (GCTC). The dignitaries were welcomed and presented a floral bouquet and memento by Shri. C.D Jadeja, Executive Registrar, Prof. (Dr.) N.K. Chaudhary, Dean of School of Cyber Security and Digital Forensics, and Air Commodore K.R. Thaakar, Dean of SPSSS. The event began with Air Commodore Thaakar delivering the welcome address.

The Inaugural Address was delivered by Hon'ble Vice-Chancellor, Dr. J.M. Vyas who called this event a landmark occasion. He enlightened the gathering with the genesis of Homeland Security courses in the university and the unique concept of Preventive Forensics and its linkage with the security. Shri Shekhar Dutt discussed the growth of terrorism in detail and touched upon the Jihadi terrorism in Kashmir. Air Commodore K.R. Thaakar presented a vote of thanks. The second session comprised expert talks. Air Marshal (Dr.) M Matheshwaran delivered a talk on 'India's balancing act in the context of its security in the aftermath of Russia-Ukraine conflict'. He stated that India needs to maintain its Strategic Neutrality in order to strengthen its military and strategic relations with Western countries as well as Russia. Another guest talk was delivered by Shri. Sanjeev Tripathi, IPS (Retd.)on 'Need to counter false Pakistan narrative on Kashmir issue' and highlighted that social media is becoming a major tool for Pakistan to set counter development narrative over Kashmir issue.

In the third session, a panel discussion and two expert talks were planned. The first Panel Discussion was on the topic "Trends in Geo-politics & Corporate Security, Industry Academia Cooperation and Careers in Intel & Security" which was moderated by Col S.M. Kumar. This was followed by an expert talk by Lt Gen K.J. Singh PVSM, AVSM & Bar, former Army Commander of Western Army Command, on 'Emerging Dynamics in Afghanistan' and emphasized that India needs to further strengthen its soft power in order to manage Islamic extremism. Shri Zafar Sareshwala, former Chancellor of Maulana Azad National Urdu University, delivered an expert talk on 'Communal Harmony and De-radicalization'. The speaker stated that community focus should be on creating education, business opportunities, entrepreneurships and jobs to make them financially strong. The fourth and final session of the day had a second panel discussion on "Trends in cyber security, convergence of physical and cyber security and bridging the skill gap", which was again moderated by Col S.M. Kumar. In the evening a dinner was hosted by NFSU for the delegates and the faculty members of SPSSS.

On Day-2 of the NFSU Security Colloquium, the delegates visited various Centers of Excellence of NFSU. In addition, special 45-minute interactive sessions with the students were held throughout the day by industry leaders such as Col S.M. Kumar, Col Sanjeev Relia, Shri Vikas Goyal, Shri Adhiraj Banerjee, Shri Sachin Punni, Capt Shakil Ahmed, Shri Shekhar Nalawade, and Shri Samir Kumar Jha.

On this occasion, Prof. (Dr.) Purvi Pokhariyal, Dean of SLFJPS, welcomed the international guests with a bouquet of flowers and introduced Prof. Stephen G Barnes, who is an expert in litigation and the Assistant Dean, Graduate and International Programs, Penn State Law, Penn State University, Pennsylvania. She touched upon the importance of learning and comparing the Constitution of various countries. Prof. Barnes gave an introduction to the U.S. Constitution and Judicial Review. He focussed on the powers, federal structure, rights and responsibilities of the states, and the concepts embodying the U.S. government.

Professor Dubin spoke on 'comparative human rights with a special focus on torture, solitary confinement and policing'.
