HON. HOME MINISTER LAYS FOUNDATION AT LUCKNOW FOR FORENSICS INSTITUTE AFFILIATED TO NFSU







On 1st August 2021, Hon'ble Union Home Minister, Shri Amit Shah laid the foundation stone of the Uttar Pradesh State Institute of Forensic Sciences (UPSIFS) at Lucknow affiliated to the NFSU. The Institute would conduct graduation, P.G. and Ph.D. courses for the students in the fields of Forensic Science, Behavioural Science, Civil & Criminal Law, Police Science, Criminology and related areas. It will also train scientists working in forensic labs and police personnel by developing professional skills for scientific investigation of cases of complex crimes. A Centre of Excellence for DNA would also be established and run by the NFSU on a five acre land within the campus of the Forensic Sciences Institute. This Center of Excellence will be the most advanced centre in the country and will help in developing the latest technology and research in the field of DNA testing. Speaking on the occasion of foundation stone laying ceremony at Piparsand in Lucknow, Shri Amit Shah said that this first-of-its-kind institution would pave the way for research and modernisation of policing in the country. He further added that the Centre of Excellence for DNA would be the country's most advanced research centre.

On this occasion, a MoU in this regard was signed between the Government of Uttar Pradesh and NFSU by the Addl. Chief Secretary of Home Department, Govt. of U.P., Shri Awanish Awasthi and the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas. Besides these dignitaries, the event was attended by the Hon'ble Chief minister of U.P. Yogi Adityanath, Hon'ble Deputy C.M. Shri Keshav Prasad Maurya, Hon'ble Deputy C.M. Dr Dinesh Sharma, DGP Shri Mukul Goel IPS, ADGP Technical Services, Shri Sandeep Salunkhe IPS, Campus Director of NFSU's Gujarat Campus, Prof. (Dr.) S.O. Junare and number of senior officials.



NFSU CO-HOSTS INTERNATIONAL CONFERENCE ON CRIMINOLOGY & FORENSIC SCIENCE





3rd International Conference on Criminology and Forensic Science in the Global South was organized by University of Dhaka, Bangladesh in collaboration with National Forensic Sciences University, India and Ryukoku University, Japan on 8th August - 9th August 2021. It was inaugurated by Dr. A. S. M. Maksud Kamal, Vice Chancellor (Education), University of Dhaka and Professor, Department of Disaster Science and Management, University of Dhaka, Bangladesh. Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas delivered a Key Note Speech on 'Forensic Science Challenges in Indian Subcontinent Region and Way Ahead'. He spoke on the role of Forensics that it can play in this region to strengthen the criminal justice delivery system. MoU WITH SUPER RECOGNIZERS INTERNATIONAL, UK





Super recognizer are individuals who possess an uncanny knack in remembering the facial features of a person even if they have met them briefly. This exceptional skill of recognizing people can be developed to apprehend criminals. This technique is both, unique and unknown to the existing Indian investigative agencies.

A MoU was signed between Super Recognizers International, UK and NFSU on 7th July 2021. This MoU will lead to introduction of a unique course to identify and train individuals with innate cognitive abilities to be super recognizers who in turn, can be useful in identifying suspects captured on CCTV or any other recording device. Dr. J.M Vyas, Hon'ble Vice Chancellor of NFSU, expressed his appreciation on introducing and implementing this new approach that will revolutionize and impact the field of forensic science and the society at large. The MoU was signed by Mr. Mike Neville, CEO of Super Recognizers International, UK and Prof. (Dr.) S.O Junare, Campus Director of NFSU at Gandhinagar. This collaboration was initiated by Dr. Surbhi Mathur, Forensic Multimedia expert and Senior Assistant Professor of NFSU, duly assisted by Ms. Krittika Sood and Ms. Ujaala Jain, both Research Assistants at NFSU.

WORKSHOP ON RAPID DNA SOLUTIONS FOR LAW ENFORCEMENT



As a part of the activity of "NFSU-Thermo Fisher Center of Excellence in DNA Forensics," a first collaborative workshop was virtually organised jointly by Thermo Fisher Scientific and NFSU on 'Rapid DNA Solutions for Law Enforcement' on 18th August 2021. Dr. J.M Vyas, Hon'ble Vice Chancellor of NFSU delivered the inaugural address encompassing the significance and impact of DNA solutions. This was followed by Dr. Bhargav Patel, Senior Assistant Professor of NFSU, who discussed the fundamental principles of DNA and its significance as a evidence at a crime scene. He was

followed by the global speakers, Mr. Tim Schellberg, Director Fred Harran, Detective Sergeant Glenn Vandergrift and Col. Andrea Berti. Mr. Tim and Col. Andrea provided insights into Rapid DNA technology regulations including how Rapid DNA technology is implemented in Italy. With their experience, Director Fred and Detective Sergeant Glenn enlightened on how Rapid DNA process at the police stations have shown tremendous success in reducing crime rate. A unique feature of the event was that all the workshop sessions were presented in two separate languages, English and Hindi, to make it convenient for the police personnel of India. The quizzes and elaborate Q&A sessions made the event interesting as well as educative. The workshop was attended by more than 250 participants from all over Asia with a significant number from India. In addition, 52 young IPS officers who were at NFSU for a training program, also participated in the event.

WEBINAR ON DIGITAL FORENSICS AND INCIDENT RESPONSE





SPECIAL TRAINING FOR IPS PROBATIONERS AT NFSU







A total of 178 IPS probationers participated in a special training module in Forensic Science conducted in two batches at NFSU. The first batch of 100 IPS probationers attended training at NFSU, Gandhinagar from 9th to 13th August 2021 and the second batch of 78 IPS probationers were trained from 16th to 20th August, 2021. Some of the topics covered during the training were Police Forensic Interface, Forensic Jurisprudence, Investigation of White Collar Crime, Ballistic Identification System, Psychological Techniques of Investigation, Role of Forensic Science in Investigation of Crimes, Emerging Trends in Multimedia Forensics, CCTV Forensics, Dark Net, and Crime Scene Management. At the end of the training capsules, Hon'ble Vice-Chancellor of NFSU, Dr. J.M. Vyas addressed the IPS probationers and wished them bright future.







CYBER SECURITY TRAINING FOR POLICE ACADEMY OF CAMBODIA

POLYGRAPH TRAINING FOR MALDIVES POLICE OFFICERS





School of Forensic Psychology (SFP) at NFSU conducted a special 5-week training programme on Polygraph for the police officers of Maldives from 5th July to 6th August 2021. Their visit began with detailed interaction with the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas who gave a broad perspective of the prevailing status of forensic science and the role of polygraph in it. This was followed by a discussion with the Campus Director of NFSU's Gujarat Campus, Prof. (Dr.) S.O. Junare who provided an overview on NFSU. In the inaugural function of the course, Air Commodore Kedar Thaakar, Dean of SFP, enlightened the officers with the role and facilities of the school while Mr. Vishal Parmar, Coordinator of the programme, briefed about the conduct of the course. The training programme comprised both, theory as well as practicals in various aspects of Polygraph such as introduction to basics of neuro-physiology of crime, theories, administration of polygraph, approaches to question preparation, scoring, analysis and report writing of polygraph. It was an intense training program where the mock crime scene was constructed and the officers got an opportunity to undergo hands-on training on polygraph. The course was conducted by the faculty of School of Forensic Psychology comprising Dr. Priyanka Kacker, Dr. K.K. Mishra, Dr. Nandita Chaube, Mr. Vishal Parmar and Ms. Krupa

Nishar. Major practical training was also conducted at the Directorate of Forensic Science (DFS) of Gujarat under its expert, Ms. Amita Shukla, Dy. Director at DFS, to understand the in-depth application of the Polygraph system in criminal cases. At the culmination of training, the officers had another interactive session with Dr. J.M. Vyas who later presented them with the certificates. The training was planned by Prof. (Dr.) N.K. Chaudhary, Head of the Centre of International Relations and was coordinated by Mr. R.N. Guna, Deputy Director, Training at NFSU.



TRAINING ON CYBER SECURITY FOR PUBLIC PROSECUTORS OF GUJARAT

TRAINING COURSES BY DELHI CAMPUS OF NFSU

As a part of National Mission for Safety of Women launched by Govt. of India, Delhi Campus of NFSU conducted four online courses on Forensic Examination in Sexual Assault Cases during July and August, 2021, in which 91 officers from Medical, Judiciary, Prosecution, Police and Forensic Scientists participated. Similarly, online Induction Course in Forensic Science was conducted from 9th to 13th August 2021 in which 10 newly recruited Judicial Officers and Prosecution Officers participated. During the course, application and latest advances in Forensic Science was deliberated. A 5-day Certification Course on 'An Overview of Video Surveillance Systems' was jointly organized for the first time by Centre of CCTV research, RV College of Engineering, Bengaluru and NFSU from 30th August to 3rd September 2021. The course mainly focused on Video Surveillance Systems, Video Footage Auditing, Video Analytics, Communication and Networking Aspects in CCTV installation, AI on the Edge, CCTV Forensics, etc. Students and faculty members of various academic and technical institutions as well as industry members attended in large number. The course witnessed the experts from industry and academia delivering the talk and sharing their experiences with the participants. FROM THE FREEDOM MOVEMENT...

CHAURI CHAURA – TIME TO RE-EVALUATE THE INCIDENT







The Chauri Chaura incident is a decisive moment in the history of the Indian freedom struggle – an incident whose true significance is yet to be fully assimilated. Chauri Chaura in the Gorakhpur district of the United Provinces (modern-day Uttar Pradesh) came to prominence during the independence movement after a violent incident between the British Indian police and political activists.

A nationwide Non-Cooperation Movement led by Mahatma Gandhi was launched in 1920. In February 1922, the region that is now called eastern Uttar Pradesh was driven by the Non-Cooperation campaign against the British colonial administration. Two days before the incident, on 2nd February 1922, volunteers participating in the Noncooperation movement led by a retired soldier of the British Indian Army named Bhagwan Ahir, protested against high food prices and liquor sales at Gauri Bazaar. The demonstrators were beaten back by the local Daroga (Inspector) Gupteshwar Singh and other police officers. Several of the leaders were arrested and put in the lock-up at the Chauri Chaura police station. In response to

this, a peaceful protest was called on 4th February to express their outrage at police repression.

On 4th February, around 2,500 protesters led by Bhagwan Ahir assembled in a village called Chotki Dumri and began marching towards the market lane at Chauri Chaura, shouting anti-British slogans, to picket the Gauri Bazaar Liquor Shop. Armed police were dispatched and in an attempt to frighten and disperse the crowd, Inspector Gupteshwar Singh ordered his 13 local policemen to fire warning shots into the air. This only agitated the crowd who began to throw stones at the police. With the situation getting out of control, Sub-Inspector Prithvi Pal ordered the police to open fire on the advancing crowd, killing three and wounding several others. In the ensuing chaos with the crowd's unexpectedly assertive reaction to the gunfire, the heavily outnumbered police fell back to the shelter of the police chowki while the angry mob advanced. Infuriated by the gunfire into their ranks, the crowd set the chowki ablaze, killing all of the Indian policemen including Inspector Gupteshwar Singh and the constables trapped inside. A total of 23 victims were burned to death, although several appear to have been killed by the crowd at the entrance to the chowki and their bodies thrown back into the fire.

In response to the killing of the police, the British colonial authorities declared Martial Law in and around Chauri Chaura. Several raids were conducted and hundreds of people were arrested. Appalled at the outrage, Gandhiji went on a five-day fast as penance for what he perceived as his culpability in the bloodshed and on 12th February 1922, the Non-co-operation Movement was halted as a direct result of the Chauri Chaura tragedy. A total of 225 people were brought to trial at Gorakhpur Sessions Court of Judge H. E. Holmes, on charges of "rioting and arson" in conjunction with the Chauri Chaura affair. Of these, 6 died while in police custody, 2 were sentenced to two years imprisonment, while 170 were sentenced to death by hanging and 47 were acquitted on 9th January 1923, following conviction in a trial which lasted eight months.

A storm of protest erupted over the verdicts, which were characterised as "legalised murder" by Indian Communist leader M.N. Ray who called for a general strike of Indian workers. After the appeal by certain politicians, on 30th April 1923, The Allahabad High Court pronounced the final judgement of the case - 19 people were sentenced to death by hanging, 14 people were sentenced to life imprisonment, 99 were sentenced to imprisonment between 2 to 8 years, and rest of the 38 people were acquitted. The 19 people that were convicted were hanged between 2nd to 11th July 1923. Ram Narain Tripathi, grandson of Meghu Tiwari, who was among the 19 hanged by the British, says "In Chauri Chaura, they just didn't accept police brutality like in Jallianwala Bagh, they retaliated. It was the first and last event of its kind in the freedom movement."

On 4th February 2021, Hon'ble Prime Minister Narendra Modi inaugurated the Chauri Chaura Centenary Celebrations by video link, and released a postage stamp to mark the centenary of the event. He said "For a number of reasons, whenever we spoke of Chauri Chaura earlier, it was portrayed as an ordinary act of arson. But we must see the circumstances for the fire, the reasons for it – that is just as important. The fire wasn't lit in the thana – it burnt in the hearts of the people."







While the internet has made our lives very easy, it has also given birth to Cyber Crime which poses a serious challenge to the privacy of citizens, financial institutions, critical infrastructure and even to the national security of not only India but also all other countries.
