On 14th October 2021, Hon'ble Union Minister of Home Affairs and Minister of Cooperation, Shri Amit Shah, laid the foundation stone for the new Campus of NFSU in Goa. He performed Bhoomi Pujan and Shilanyas for the permanent campus at Dharbandora in Goa and inaugurated a temporary campus made ready at Curti in Ponda. The events were attended by the Hon'ble Chief Minister of Goa, Shri Pramod Sawant; Hon'ble Union Minister of State for Tourism and Ports, Shipping and Waterways, Shri Shripad Naik; Hon'ble Deputy Chief Minister of Goa, Shri Chandrakant Kavlekar; Hon'ble Minister of Public Works and Museum of Goa, Shri Deepak Pauskar, Hon'ble Member of Rajya Sabha, Shri Vinay Tendulkar, Union Home Secretary, Shri Ajay Kumar Bhalla IAS; Additional Secretary in the Ministry of Home Affairs, Ms. Punya Salila Srivastava IAS and many other dignitaries. All the dignitaries were received by the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas. He was accompanied by the Campus Director of NFSU's Gujarat Campus, Prof. (Dr.) S.O. Junare and the Executive Registrar of NFSU, Shri C.D. Jadeja who were instrumental in overseeing all the arrangements.

All the dignitaries were welcomed and felicitated by Shri C.D. Jadeja. In his welcome address, Dr. J.M. Vyas briefed about the plans for developing the Goa Campus of NFSU and the facilities that will be created. He informed that the campus will start functioning from the current academic session of 2021-22 with four courses i.e. 5-year B.Sc.-M.Sc. Integrated course in Forensic Science, M.Sc. in Forensic Science, M.Sc. in Digital Forensics & Information Security and





M.Sc. in Cyber Security with a total of 200 students. He expressed confidence that the new campus in Goa will go a long way in producing qualified forensic experts which will help strengthen the criminal justice delivery system. Speaking on the occasion, Shri Pramod Sawant brought out that Goa is rapidly emerging as an educational hub and innovation centre of the country, and a NFSU campus is a step further in this direction.

Addressing a gathering after performing pooja on a 50-acre plot allotted to NFSU at Dharbandora in South Goa, Shri Amit Shah said that the purpose behind generating forensic experts is to punish the dangerous and habitual criminals which is possible only with the help of scientific evidence made available by forensic scientists. He said that the government is planning to make it mandatory for forensic teams to visit the scene of all crimes that attract imprisonment of more than six years. To achieve this, the country needs around 600 forensic science teams with a mobile forensic van to cover all the districts of the country which in turn requires around 30,000 to 40,000 forensic experts. The Hon'ble Home Minister informed that this campus will not only teach forensic science to the students but also conduct diploma courses for police officers, judicial officers, cyber security experts and security staff of private companies. He urged the Vice Chancellor of NFSU to plan diploma courses in the Goa campus on subjects related to tourist safety, coastal policing and drugs & narcotics. Shri Amit Shah urged the students to join the forensic university and expressed hope that in future, Goa will have the reputation of a State producing largest number of forensic scientists.

Prof. (Dr.) S.O. Junare presented the vote of thanks. He started with thanking Shri Amit Shah for not only his valuable guidance and sparing time but also for the development, expansion and upgradation of NFSU. In addition, he profusely thanked Shri Pramod Sawant and other dignitaries for gracing the occasion as well as their guidance and sustained cooperation in setting up the campus. He also expressed gratitude to the guests, media personnel, and all those who worked day and night to make the event successful. The function was attended by eminent citizens from different fields, academia and students, maintaining strict COVID-19 protocol.













#### **TEAM NFSU WORKS ON WAR FOOTING FOR GOA CAMPUS**

When the Hon'ble Union Minister of Home Affairs and Minister of Cooperation, Shri Amit Shah laid the foundation stone for the permanent campus at Dharbandora in Goa and thereafter inaugurated a temporary campus at Curti in Ponda on 14th October 2021, it also marked the culmination of a huge dedicated effort by the Team NFSU. It was a novel experience for the members of NFSU to organize two back-to-back events of such high stature at a far away location, outside the state of Gujarat. While a 50-acre piece of land was earmarked for establishing the NFSU Campus, its formal handing over and preparing this undulated plot covered with wild vegetation, for Bhoomi Pujan and Shilanyas, followed by the inauguration ceremony to be attended by large number of guests at Dharbandora, located 45 Km away from Panjim, a major city and a capital of Goa, was a huge challenge. It required close coordination and lots of resources from various departments such as Land, Revenue, PWD, Electricity, Water Supply, Roads & Buildings, Forest, Police, Tourism and many more departments especially the local collectorate. Equally prompt and quality output was needed from the number of contractors as also the synchronisation of different preparations. Unseasonal and incessant rains further increased the degree of difficulty.

15 Km to the West of Dharbandora was the venue of the next event - inauguration of the temporary campus at Curti in Ponda by the Hon'ble Minister. In order to begin the courses immediately for their youth, the Government of Goa had identified a recently constructed guest house of the Animal Husbandry department for setting up the temporary campus at Curti, Ponda. It was a wonderful pro-active step on part of the State Government to provide an unused double storied building having large number of rooms. But preparing it for a











university campus needed major civil work to convert the guest rooms into class rooms and laboratories. The heavy rains and humid weather also called for variety of repairs and clearing of the surroundings full of wild growth. Being a small town, it had its own limitations of shortage of skilled workers, required items, internet connectivity, electricity supply, etc. Here too, rain was playing a spoil sport.

It was a race against time. It called for unprecedented effort, initiative and coordination. It was a testing time. And, as expected, Team NFSU rose to the occasion. Led from the front by the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas, the team was never short of decisions, advice and motivation. On ground, Campus Director of Gujarat Campus, Prof. (Dr.) S.O. Junare and the Executive Registrar of NFSU, Shri C.D. Jadeja, put in a well-thought out plan, oversaw every activity till completion, and coordinated at the highest level, bordering, at times, on to negotiations. They ensured that the preparations are not hampered. Dr. Malay Shukla, Assistant Professor of NFSU, was the quintessential'linch pin' who was involved in everything everywhere! He closely monitored each activity, putting in long hours of extreme hard work. A similar hard work was put in by Shri Marmik Shah looking after civil works, Shri Nilay Mistry for ICT related tasks, Dr. Pranav Dave for the entire arrangements and conduct of 'Bhoomi Pujan', Shri Bhavin Vadaliya and Shri Shailendra Jadeja in administrative work, ably supported by Shri Vishnu Thakor and Shri Vipul Thakor. Air Commodore R.N. Gaekwad also pitched in during last few days with his vast experience. The Team NFSU was fortunate to receive complete support and guidance in every activity from the local ex-MLA, Shri Ganesh Gaokar and NFSU's alumnus Shri Amol Deshmukh. Besides this, it must be acknowledged that various departments of civil administration put in tremendous effort in every sphere of activity. # UNION MINISTER OF LAW AND JUSTICE, SHRI KIRAN RIJIJU INAUGURATES SCHOOL OF LAW, FORENSIC JUSTICE & POLICY STUDIES





On 27th September 2021, Hon'ble Union Minister of Law & Justice, Shri Kiren Rijiju, inaugurated the newly established School of Law, Forensic Justice & Policy Studies (SLFJPS). It was a matter of privilege for the National Forensic Sciences University to have the Hon'ble Union Minister for the inaugural ceremony. NFSU also had the honour to host Hon'ble Chief Minister of Gujarat, Shri Bhupendra Patel; Hon'ble Judge of Supreme Court of India, Mr. Justice M.R.Shah; Hon'ble Acting Chief Justice of High Court of Gujarat, Mr. Justice R.M. Chhaya; Hon'ble Minister of Law and Justice in the Government of Gujarat, Shri Rajendra Trivedi; Hon'ble Minister of State of Home in the Government of Gujarat, Shri Harsh Sanghavi; and Hon'ble Chairman of the Executive Committee of the Bar Council of India, Shri Apurba Kumar Sharma. Besides these dignitaries, number of former and seating Judges of the Supreme Court, High Court and District & Sessions Court, as well as members of the Bar Council and Advocates of the High Court graced the event. All the dignitaries were received and conducted by the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas. He was accompanied by the Campus Director of NFSU's Gujarat Campus, Prof. (Dr.) S.O. Junare, the Executive Registrar of NFSU, Shri C.D. Jadeja, and Prof. (Dr.) Purvi Pokhariyal, Dean of SLFJPS who were instrumental in overseeing all the arrangements.











At the outset, Dr. J.M. Vyas, Hon'ble Founder Vice Chancellor of NFSU welcomed Shri Kiren Rijiju with a specially designed copy of the Constitution of India and a traditional shawl, and presented a memento to him. Dr. Vyas similarly welcomed other dignitaries on the stage - Shri Bhupendra Patel, Mr. Justice M.R.Shah, Mr. Justice R.M. Chhaya, Shri Rajendra Trivedi, Shri Harsh Sanghavi, and Shri Apurba Kumar Sharma. Thereafter, Dr. Junare and Shri Jadeja welcomed other dignitaries.

Dr. J.M. Vyas delivered the opening address and informed that while we had made a humble beginning with just five courses, today we are conducting more than 70 courses. He further stated that following the vision of our Hon'ble Prime Minister, Shri Narendra Modi, we are now embarking on opening NFSU's campuses and training centers in different states of the country and even abroad. Laying down the long term plan of the university, he stated that besides focusing on the core area of forensic science, NFSU is determined to elevate the standard of criminal justice delivery system through academic excellence in all its three elements - law, forensic sciences and policing & security. He highlighted that establishment of SLFJPS is step in that direction.

Speaking on the occasion, Gujarat's Hon'ble Law and Justice Minister, Shri Rajendra Trivedi mentioned that as incidences of use of technology in committing of crime is increasing, there is need to upgrade the entire system with knowledge and technology. He hoped that this new law school would meet this requirement by producing tech-savvy experts in the country. Hon'ble Supreme Court Judge, Mr. Justice M.R. Shah was fascinated with the concept of the new law school. In his address, Justice Shah highlighted that as today's students are future lawyers and legal advisors, the country needs to train its human resources with knowledge and experience. He expressed confidence that a law school like this can surely fulfill such a need with its systematic training and scientific approach.

In his address, Hon'ble Chief Minister, Shri Bhupendra Patel said that the school will provide techno-legal experts who will be well equipped with knowledge. He wished that the new school will be able to blend Data Science with Law to help legal professionals provide evidence during trials and help deliver speedy justice and check cyber crime. He further stated that, in turn, it will offer employment opportunities to the youth.

Shri Kiren Rijiju began his address by expressing happiness at the presence of so many Supreme Court and High Court judges. He stated at the outset that the three separateorgans, the Judiciary, Executive and Legislature, are very important and are working together for the interest of the nation, and there isn't a turf war. He, however, noted that many a times, justice is delayed due to lack of evidence but hoped that the students trained at this school will help fulfill this shortcoming in future. Hon'ble minister expressed confidence that this new school which is blended with technology and law, would evolve a strong system to check cybercrime and prove useful in imparting knowledge and training in Forensic sciences. He declared that the Central Government would provide all required assistance to NFSU as it is capable of disseminating its expertise throughout the country with its farsighted vision.

Prof. (Dr.) S.O. Junare, Campus Director of Gujarat campus of NFSU delivered a vote of thanks. He began with thanking Shri Kiren Rijiju for the valuable guidance and sparing time from his busy schedule. In addition, he profusely thanked all the dignitaries for gracing the occasion. Prof. Junare also thanked the guests, media personnel, and all those who worked tirelessly to make the entire visit successful. The event was conducted by Dr. Astha Pandey, Associate Professor of NFSU, and ended with singing the national anthem by all the attendees. The function was attended by the faculty, staff and students of NFSU, maintaining strict COVID-19 protocol.

#### **NFSU TEAM VISITS TRIPURA FOR SETTING UP CAMPUS**

#### **ACTIVITIES**

#### NFSU CELEBRATES NATIONAL CYBER SECURITY AWARENESS MONTH







NFSU celebrated October 2021 as the National Cyber Security Awareness Month under the aegis of its School of Cyber Security and Digital Forensics. Dr. J.M. Vyas, Hon'ble Vice-Chancellor, inaugurated the event on 6th October, 2021 by lighting the lamp. Later Dr. Vyas addressed the students with an enlightening speech laced with number of points to ponder upon and memorable anecdotes. He brought out that there are three modes of learning - Awareness, Education and Training, and thereafter pressed on the need to have a deeper knowledge and awareness of Cyber Security, to avoid becoming a victim of Cyber Crimes. He also appreciated the organizers for the series of events and talks planned to promote awareness throughout the month. Prof. (Dr.) Naveen Kumar Chaudhary, Dean School of Cyber Security and Digital Forensics, highlighted the theme of the awareness campaign - 'Do Your Part' and 'Be Cyber Smart'. He also shed light on various events to follow in the awareness campaign. He motivated the students to participate wholeheartedly and shared profound words of wisdom to set the wheels in motion of the month-long celebration.









#### **CYBER DEBATE**

The first event of the National Cyber Security Awareness Month, was the Cyber Debate Competition. The topic of the debate was - "Is India ready for cyber warfare?" A total of 12 participants across the schools, six for the motion and six against it, enthusiastically participated and presented their passionate arguments. The key points brought out by those for the motion during this debate was

India's high ranking on the US Telecom's Cyber Security Index, as compared to the ranking of our opponents, China and Pakistan. The increasing awareness about cyber security and the funding promised by the government were also brought up as good prognostic factors. They finished strongly with the idea that today's youth is more cyber aware than ever before which will go a long way in making India ready for cyber warfare.

Those debating against the motion, countered by bringing up the cyber-attacks at Mumbai and the response time that it took. The frequency of cyber-attacks against the government websites was also brought out as a valid argument. The event concluded with the students and audience realizing the gravity of cyber attacks which was not just restricted to personal cyber-attacks but was a threat to the nation's sovereignty. The event was won by Edmore Chikukwa, an international student from MBA (Homeland Security) with Priya Kaushal of M.Sc. (Forensic Psychology) being the first runner up. Air Commodore K.R. Thaakar, Dean SPSSS and Dr. Dharmesh Silajiya, Dean SFS & SMLS, served as the judges for the debate.



#### **DRONE FORENSIC HACKATHON**

Drone Forensic Hackathon was the second competition organized as a part of National Cyber Security Awareness Month. It was held in the highly sophisticated cyber labs where Prof. (Dr.) Naveen Kumar Chaudhary and Mr. Nilay Mistry initially guided and later judged the students. Many teams participated in the event where the students raced against time to carefully attend to their pictures and find artefacts from the image. In the end, the judges asked the participants questions and examined their thought process. The students were also asked to fill questionnaires and chain of custody forms to add the practical touch to this event. This event was won by Yash Shah, Jay Makwana, and Furkan Kanuga of M.Tech (Cyber Security).





#### **CYBER ADALAT**

Cyber Adalat was the third event that was specially designed to equip our future forensic experts in the field of Cyber Security, Digital Forensics and Forensic Psychology to understand the proceedings of the court as also to equip our budding lawyers from the newly opened School of Law, Forensic Justice

and Policy Studies. A total of five teams participated where each team consisted of a public prosecutor, a defense lawyer and a forensic expert. The event began with plain and simple outlining of the facts of the case. Subsequently, the budding lawyers were assessed on their case presentation and research while the forensic experts presented their forensic reports. All the participants were cross scrutinized by the judges very encouragingly. In the end, Priya Kaushal from M.Sc. (Forensic Psychology) bagged the title of 'Best Forensic Expert' while Garva Mathur from B.Sc. LLB emerged as the 'Best Budding Lawyer'.



#### **CYBER TABLETOP EXERCISE**



#### IN A FIRST, NFSU CONDUCTS DOPING TEST FOR RECRUITMENT

One often hears about doping tests being conducted during various sports events. But in a first activity of its kind, NFSU conducted doping tests on the candidates appearing for the physical test for the recruitment of Police Inspectors. On directions of Gujarat Public Service Commission (GPSC), a team of NFSU's Centre of Excellence for Research & Analysis of NDPS undertook the mammoth exercise. The team led by Dr. Astha Pandey, Head of the Centre and Associate Professor, carried out a six-band test on as many as 1100 candidates which entails testing presence of six different tests. While Gujarat can take pride for being the first state to conduct such a test as a part of recruitment, the candidates also deserve compliments as none of them tested positive.





#### VISIT BY MADHYA PRADESH TEAM




#### NFSU PARTICIPATES IN STRATEGIC BORDER INFRASTRUCTURE CONFERENCE

#### TRAINING ON "WILDLIFE FORENSICS" FOR MADHYA PRADESH FOREST OFFICERS

#### TRAINING OF RESEARCH ASSISTANTS FOR BPR&D PROJECT

NFSU is undertaking a project titled 'A study of factors responsible for recidivism' funded by the Bureau of Research & Development (BPR&D), MHA. As a part of the project, a 4-week long training was conducted at the School of Behavioural Sciences (SBS) for the Project Director, Ms. Krupa Nishar of the School of Forensic Psychology and eight other research assistants. The training comprised topics like Rapport Building & Clinical Interviewing skills, Raven Standard Progressive Matrices, Millon Clinical Multiaxial Inventory-III, Hare Psychopathy Checklist – Revised, and self-report measures. The training also included number of visits to Sabarmati Central Prison at Ahmedabad for hands-on-training experience on administration and scoring of the aforesaid tools. During

the training, Smt. Anupama Nilekar Chandra, IG(Training) at BPR&D also visited NFSU on 13th August 2021. The training was conducted by Dr. Ravikesh Tripathi, Dr. Priyanka Kacker, Dr. Biswajit Dey, Dr. K. K. Mishra, Ms. Priyanka Samuel and Ms. Rupangi Shah under the overall guidance of Dr. Smita Pandey, Dean of SBS and the then Dean of the School of Forensic Psychology, Air Commodore K. R. Thaakar. At the culmination of the training programme on 1st September 2021, the trainees organised a thanksgiving event and presented potted plantlets as a souvenir to the experts and the organizers. Subsequently, the research trainees embarked for data collection at the Tihar Jail in New Delhi, Dasna Jail at Ghaziabad and Bhondsi Jail at Gurugram.

#### TRAINING COURSES ON FORENSIC EXAMINATION IN SEXUAL ASSAULT CASES

New Delhi Campus of NFSU (erstwhile NICFS) has been regularly conducting Special Training Courses on Forensic Examination in Sexual Assault Cases as envisaged under the National Mission for Safety of Women launched by Govt. of India. #### PATENT GRANTED TO NFSU FACULTY

Dr. Jayrajsinh Sarvaiya, Senior Asst. Professor at School of Engineering and Technology along with Ms. Anjali Bavishi, alumni of Food Forensics at NFSU, were awarded Indian Patent (PATENT NUMBER 377040) for their invention on Tetrahydrocurcumin containing health food in October 2021 after three years of proceedings. This invention offers alternative of curcumin based products which suffer from many practical and application limitations. The Food Forensic laboratory of School of Engineering and Technology has also filed other national and international patents in New Product Development and on-spot sensor domains, some of which involves collaborative work with foreign companies.





#### SUCCESSFUL INVESTIGATION OF STRUCTURAL FAILURE CASE

Dr. Merool Vakil, Asst. Professor for Forensic Structural Engineering at the School of Enginering & Technology along with her team of Prof. R.J. Shah and Mr. Abhi Shah, have successfully investigated a challenging case of facade failure of the U.N. Mehta Institute of Cardiology & Research Centre at Ahmedabad. A 32 m high and 14 m wide façade structure of a 8-storied R.C.C. framed pediatric cardiac hospital building was damaged on 18th May 2021. In order to ascertain the exact cause of this incident, Dr. R.K. Patel, Director of the institute, had requested the NFSU to assist in 'Assessment of damaged façade structure' as an independent agency. In turn, the NFSU team of the School of Engineering & Technology visited the site number of times, studied the samples of failed structure, reviewed relevant structural, architectural and fabrication drawings, even inspected the structure closely from a crane, and performed detailed evaluation. The team also studied contract and tender documents, interviewed the contractor, owner and PMC representatives to arrive at a detailed investigation report which has been well appreciated. The progress was periodically monitored and valuable suggestions offered by the Hon'ble Vice Chancellor of NFSU, Dr. J.M. Vyas. In the past also, the team has investigated many structural failure cases, root cause of road damage, investigation of old structures and those damaged by fire, and carried out testing of various construction materials.

Dr. Rakhi Agarwal, Associate Professor at the NFSU's School of Forensic Science was honoured with "Dr S N Acharya Felicitation Award" by

# TINDIAN SAILORS IN REVOLT SIX HOURS BATTLE WITH SIX HOURS BATTLE W









#### A MUTINY THAT PROPELLED FREEDOM

In the saga of Indian independence, if there is one event which is conspicuous by its absence, it is the Naval Mutiny of 1946. A string of mutinies in the Army, Navy and Air Force, kept out of public glare by the British, culminated into the 1946 mutiny by the Indian Naval sailors which brought the might of the British Empire to its knees, or, at least, forced the early British departure from India as they could no longer trust their armed forces. In the platinum jubilee year of this episode, it is only appropriate that the Naval uprising be revisited so as to appreciate its profound impact.

During World War II, as the Indian troops had fought alongside other countries and realised that they were not inferior either in skills or courage, they had started questioning the need for them to serve the British. This, coupled with the poor living conditions and ill treatment, made the sailors rebel. The fire of revolt was ignited at HMIS Talwar at Colaba in Bombay when the morning bugle was sounded on 18th February 1946 as not a single sailor turned up, refused to eat, struck work, and shouted slogans of 'Quit India' and 'Jai Hind'. The British ensign or the flag on HMIS Talwar was lowered and the 'Azad Hind' flag of the INA unfurled on the mast along with the flags of the Congress and Muslim League to symbolise unified action of Hindus and Muslims. The Naval Mutiny had begun.

On that day, the Naval personnel changed the name of the 'Royal Indian Navy' to the 'Indian National Navy', in the spirit of Subhash Bose's 'Indian National Army'. HMIS Talwar being a signals ship, contacted other ships and within a short period, 20,000 Indian sailors across the nation took control of 78 ships and 20 shore establishments from Karachi to Chittagong including Bombay, Visakhapatnam, Madras, Kochi, Jamnagar, Calcutta and even Indonesia, Aden and Bahrain. They also took control of the Transmission Centre at Kirkee which was the communication link between the Indian Government and the British. In Bombay, the guns fitted on the ships were pointed at the Gateway of India, the Yacht Club and the Taj Mahal Hotel, with threats to blow them up. In yet another audacious act, the young sailors also took over the Butcher Island which was the ammunition depot for the British. To express sympathy with the sailors, thousands of residents of Bombay poured out onto the streets in protest. Soon the whole city came to a standstill as the civilians showed their support with strikes, destruction of police stations, post offices and the public transport system as trains were burnt. The revolt received widespread support from public not only in Bombay but also in Karachi, Calcutta, Ahmedabad, Madras, Trichinopoly, Madurai, Kanpur and several places in Assam.

As expected, the Government reacted with full fury. Navy ships were summoned from Trincomalee in Ceylon, Tanks and Artillery guns were moved in, and the Air Force bombers made low passes in a show of strength. After the Indian troops refused to fire, British Army troops were called in which imposed curfew and were ordered to shoot at sight, killing nearly 400 people and leaving 1,500 injured. Pitched battles took place between the revolting sailors and the Army troops which had laid a siege at the Castle Barracks, now INS Angre of Mumbai, cutting off water and electricity.

The revolt was called off on 23 February 1946 after Sardar Vallabhbhai Patel made an appeal which was later echoed by Mohammed Ali Jinnah on behalf of the

Muslim League. While the uprising ended, it had witnessed a massive outpouring of public support for the mutineers. For the first time, the blood of men in uniform and civilians was spilled in a common cause. Also, the death toll in the clashes was the highest recorded until then. In a befitting recognition, the Navy honoured the two prominent leaders of the uprising, sailors B.C. Dutt and Madan Singh, by naming two yardcraft after them. Later, on the Navy Day 2001, 'Uprising Memorial' was inaugurated and opened to public at Cooperage in Mumbai.

The Naval Mutiny of 1946 was a courageous and audacious revolt by patriotic young men. This revolt was different - it was directed against the British government and not against superior officers – not a single officer, British or Indian, was harmed. Such was its impact that in 1956, Lord Clement Atlee, the British Prime Minister at the time of independence, attributed the hurried departure of the British in 1947 to the Indian National Army and the Naval Mutiny of 1946. In 1967, the British High Commissioner, John Freeman also stated that the Naval Mutiny of 1946 had raised the fear of a large-scale mutiny - "The British were petrified of a repeat of the 1857 Mutiny, and this time they feared they would be slaughtered to the last man". Unfortunately, the magnitude and significance of the Naval Mutiny have been marginalised in most historical accounts. Whatever be the reasons, it is time we remembered the brave young men who dared to defy an Empire and energised the hearts and minds of our soldiers and citizens alike.
