

MBA - Forensic Accounting and Fraud Investigation

The field of forensic accounting is rapidly expanding and is among the most in-demand careers in accounting. With the increasing number of fraudulent activities and financial crimes, the demand for forensic accountants is on the rise. MBA in forensic accounting and fraud investigation programme is designed to focus on the Prevention, Detection, Deterrence and Investigation of financial fraudulent activities. Graduates of this programme will have the skills and knowledge to detect, investigate and report on financial crimes to executive management teams and other investigative agencies.

This programme covers contemporary topics such as Fraud Prevention, Risk Management, Risk Assessment, Financial Statement Analysis and Legal and Regulatory Compliance for the early detection of frauds. MBA - Cyber Security Management

MBA - Business Analytics and Intelligence

The School of Management Studies offers a two-year full-time master's programme, MBA in Business Analytics and Intelligence for individuals who wish to specialize in Data Analytics and Intelligence. MBA - Hospital and Healthcare Management

The forensic components are essential in guaranteeing patient safety, shielding healthcare providers from legal responsibility and enhancing the quality of healthcare services.

Additionally, it emphasizes the business side of healthcare, which is becoming increasingly important as healthcare organizations face financial pressures and need to operate more efficiently. The programme promotes knowledge through applied and conceptual research relevant to healthcare management, which makes it an ideal choice for those looking to increase their chances of being hired as a Manager or Administrator in Pharmaceutical Companies, Health-tech Organizations, Insurance Companies, Hospitals, Clinics, or other healthcare-related agencies.







BBA-MBA, Five Year Integrated (Specialization in Forensic Accounting and Fraud Investigation / Financial Management / Business Analytics and Intelligence)

The BBA-MBA programme is a five-year integrated course designed for students who have completed their 10 + 2 standard. This unique programme provides a comprehensive understanding of the business world, covering basic concepts to advanced strategies. The course structure ensures that students do not have to repeat any concepts and saves them from the cumbersome admission process for MBA after graduation.

By specializing in fields such as Forensic Accounting and Fraud Investigation, Financial Management and Business Analytics & Intelligence, students can gain expertise in their chosen area of interest at an early stage. The BBA-MBA (Integrated) programme prepares candidates to become competent leaders in their field of specialization, providing them with technical and managerial skills and competencies.

- Bachelor's degree in any stream with at least 55% for General / OBC / EWS category candidates and 50% or equivalent for SC/ST and PwD category candidates and
- Minimum 5 years working experience in government recognized/ registered/ private organization at supervisory level.

MBA - Forensic Accounting and Fraud Investigation / MBA - Hospital and Healthcare Management / MBA - Business Analytics and Intelligence

- Bachelor's degree in any stream with at least 55% for General/ OBC/ EWS category candidates and 50% or equivalent for SC/ST and Pwd Category Candidates.
- Candidates appearing in the final year of the bachelor's degree can also apply subject to meeting minimum eligibility criteria in the prescribed time limit as decided by the University.

ADMISSION PROCEDURE

Admission Procedure for MBA (Executive) & MBA Programmes

- Admission to the MBA programs will be given on the following basis.
- Candidates who have appeared at Common Admission Test (current year) conducted by Indian Institute of Management can apply. In Addition to CAT, candidates are also required to apply for admission at School of Management Studies, National Forensic Sciences University separately.

OR/AND

- Candidates can also apply for the entrance exam conducted by National Forensic Sciences University.
- Merit list will be prepared based on the CAT score/Entrance exam score conducted by National Forensic Sciences University.
- 50% of the total seats will be fill-up through CAT score and remaining 50% will be fill-up through the entrance test conducted by NFSU. However, if any seats remain vacant under CAT category, it will be filled up though NFSU entrance test (NFAT) category and vice versa.

Admission Procedure for BBA - MBA (Five Year Integrated)

 Admission will be given on the basis of entrance exam conducted by National Forensic Sciences University/ Based on Merit Prepared Considering percentage in 12th examination.


