- 3. 'Sexual Harassment' includes any one or more of the following unwelcome acts or behaviour (whether directly or by implication) namely:
  - physical contact and advances; or i.
  - ii. a demand or request for sexual favours; or
  - making sexually coloured remarks; or iii.
  - iv. showing pornography; or
  - any other unwelcome physical, verbal or non-verbal conduct of sexual ٧. nature:
- The following circumstances, among other circumstances, if it occurs, or is present in relation to or connected with any act or behaviour of sexual harassment may amount to sexual harassment:
  - implied or explicit promise of preferential treatment in her employment; or
  - ii. implied or explicit threat of detrimental treatment in her employment; or
  - iii. implied or explicit threat about her present or future employment status; or
  - interference with her work or creating an intimidation or offensive or iv. hostile work environment for her; or
  - ٧. humiliating treatment likely to affect her health or safety.
- It shall be the responsibility of the Committee to follow the norms under the UGC Regulations, 2015.
- An aggrieved person is required to submit a written complaint to the ICC within three months from the date of the incident and in case of a series of the incidents within a period of three months from the date of last incident.
- Presiding Officer, ICC shall see that annual report is submitted on relevant portal for each year. This ICC shall also function as Gender Sensitization Cell. Promotional/awareness activities vis-à-vis workshops/lectures on gender sensitization as wells as prevention of sexual harassment may be organized during the orientation week.
