M.Sc. FORENSIC NURSING COURSE

Forensic nursing is a specialized area of nursing that combines nursing skills with forensic science knowledge to provide healthcare to individuals who are affected by violence, trauma, or crime. A postgraduate course in forensic nursing can provide nurses with advanced skills and knowledge to work in a range of settings, such as emergency departments, medico legal approaches in cases of abuses against women, elders and children, correctional facilities, and forensic psychiatric units.

The scope of a forensic nursing postgraduate course may include the following:

- Understanding the legal and ethical issues relating forensic nursing.
- Identifying and assessing the victims of violence, abuse, and trauma.
- Collecting and preserving forensic evidences for the scientific investigation and justice delivery.
- Providing clinical psychological care to victims of violence, abuse, and trauma and medicolegal assistance
- Coordinating with law enforcement agencies and other professionals involved in
- the criminal justice system.
- Developing the rapport & reassurance to the families of victims to provide support & counseling.
- Providing expert testimony in legal cases as an associate with the medicolegal team.

SUBMISSION OF PAPER

- Kindly specify the category (paper/ poster) while submitting the abstract.
- The paper should be ORIGINAL and UNPUBLISHED offering new insights, a new approach, or new knowledge to the body of literature.
- Paper presentation may include Original Research or Case Report.
- The abstract should be of a maximum of 300 words followed by a minimum of 5 keywords in the format given.
- All participants should email their respective abstracts before the mentioned deadline, 10th August 2024 at inpafnuscon@gmail.com
- Already registered participants in the Conference are only eligible for scientific paper presentations.

CRITERIA FOR EVALUATION

- The evaluation depends upon the presentation skills, content, topic relevancy, and answers given to the jury.
- All abstracts submitted would be published in the SOUVENIR of INPAFNUSCON.

PRESENTATION OF PAPER

- Format of Paper: The PPT should follow the format.
- The paper has to be presented in PowerPoint 2013/2010 or earlier in 16:9 ratio slides.
- A maximum of 10 slides is allowed to present. The time limit for the presentation will be 8 minutes followed by a 2-minutes discussion .
- The presentation should include an introduction, material, and methodology, information regarding collected data, major findings, conclusion, etc.
- In the case of multiple authors, only one author out of the two would be allowed to present . All Co-authors would receive the participation Certificate as co-authors.

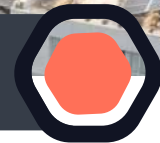
FORMAT OF PAPER: THE MANUSCRIPT SHOULD FOLLOW THE FORMAT

- Title of the paper, Name, Position with Institute name, Contact no. and Email Address.
- Approximately 300 words of abstract followed by a minimum of 5 keywords along with the final paper.
- The paper should follow the font Times New Roman size 12 (Justify alignment) and heading size 14 (aligned centrally) in MS-Word Format.
- All references should follow the MLA (8th edition) style.
- All tables and figures should be appropriately numbered.

SUBMISSION OF POSTER

- Kindly specify the category (paper/ poster) while submitting the abstract.
- The poster should be ORIGINAL and UNPUBLISHED.
- The Poster should include completed or ongoing scientific research, proposing innovative ideas, interesting case study, etc.
- The abstract should be of a maximum of 300 words followed by a minimum of 5 keywords in the format given.
- All participants should email their respective abstracts before the mentioned deadline, 10th August 2024 at inpafnuscon@gmail.com

CRITERIA FOR EVALUATION

- The evaluation depends upon the presentation skills, content, topic relevancy, and answers given to the jury.
- All abstracts submitted would be published in the SOUVENIR of INPAFNUSCON.

PRESENTATION OF POSTER

- The poster must be printed as a single flex of size 3ft length × 4 ft. width (90cm ×120 cm).
- Participants should carry printed posters along with them.
- Organizers will provide the poster board for displaying the poster presentation.
- The Poster should include following sections:- Introduction, Method and Methodology, Results, Conclusion.
- Ensure that you include the abstract title, author name and co-author name and designation.
- The allotted time for Poster presentation is 5 minutes, followed by a 2 minutes discussion.
- In cases of multiple authors, only one author among the group will be permitted to present the Poster. All Co-authors will receive the participation Certificate as co-authors.
- Only the main Presenter will receive the Winning Certificate of Achievement.

HOW TO REACH

Gujarat's capital city is Gandhinagar, located in west-central India. It is located near Ahmedabad on the Sabarmati River's banks. Gandhinagar is situated on the western terminus of the Industrial Corridor between Mumbai, the country's financial city, and Delhi, the country's political capital, about 23 kilometers north of Ahmedabad. On the west bank of the Sabarmati River, Gandhinagar is located around 545 kilometers (338 miles) north of Mumbai and 901 kilometers (560 miles) south of Delhi. National Forensic Sciences University, Gandhinagar is located at Sector 9, Gandhinagar, Gujarat-382007.

By Air:

The nearest airport to Gandhinagar is the Sardar Vallabhbhai Patel Airport is situated in Ahmedabad, which is located at a distance of 15 kilometres. It takes about 30 minute to 45 Minute roughly to reach Gandhinagar. The Sardar Vallabhbhai Patel Airport is well connected to cities across India like Delhi, Jaipur, Hyderabad, Lucknow, Mumbai, Pune, Kolkata and Nagpur among others.

By Train:

Ahmedabad: Gandhinagar is 21 kms. from Ahmedabad (Kalupur) Railway Station which is major railway station having excellent rail connectivity across India.

Gandhinagar: Gandhinagar Capital Railway Station at Sector 14 is situated approximately 5.5 kms., away from the NFSU Gandhinagar Campus. Gandhinagar Capital railway station is connected with Indore, Mumbai, Delhi and Haridwar.

By Road:

Gandhinagar is well connected with road and accessible through a strong road network and is well connected by road to cities such as Ahmedabad, Anand, Vadodara, Surat and Rajkot within Gujarat. Gandhinagar is also connected to cities such as Mumbai, and Navi Mumbai through National Highway 8A and cities like Jaipur, Udaipur, Delhi and Chandigarh through National Highway 8C. Most buses are run by the Gujarat State Road Transport Corporation and other private operators as well.
