About National Forensic Sciences University

National Forensic Sciences University, the erstwhile Gujarat Forensic Sciences University, is the brainchild of Govt of Gujarat. It was established by the Hon'ble Prime Minister of India Shri. Narendra Modiji, then Chief Minister of Gujarat, in 2009 with a sole objective of creating professional experts in the field of forensic sciences. Though the university started with conventional courses related to forensic sciences, university further introduced novel courses which are based on the requirement of the country to solve the issues related to the society. Based on the impressive successes achieved by this university within a short span of thirteen years, the Government of India has recognized its services to the student community and the professionals of the national and international origin, and has accorded the status of Institution of National Importance and also as a Central University in October 2020.

Currently NFSU has nine campuses in India, located in the states of Gujarat, Delhi, Goa, Tripura, Madhya Pradesh, Maharashtra, Assam, Manipur and Karnataka and one campus abroad located in Uganda.

The university comprises various academic schools, departments, research centres and centres of excellence spread across wide range of disciplines including Forensic Science, Cyber Security and Digital Forensics, Behavioural Sciences, Forensics Psychology, Engineering & Technology, Pharmacy, Management Studies, Homeland Security, Police Science and Security Studies, Medico-Legal Studies and Law, Forensic Justice and Policy studies, Doctoral studies and Open learning. Presently, the university offers more than 65 post graduate courses as well as integrated courses.

NFSU Dharwad is the first campus of NFSU in the southern region of India. It has been a longcherished dream to set up NFSU Dharwad in South India. The Dharwad city is located in the north western part of the Indian state of Karnataka and is an administrative district and educational hub of the state of Karnataka. Hon'ble Union Minister of Home Affairs, Shri Amit Shah laid the foundation stone for the NFSU campus at Dharwad on 28th January 2023. NFSU Dharwad Campus will be constructed on an area of 45 acres 19 gunta of land at Dharwad, Karnataka. NFSU Dharwad campus is established with the objective of strengthening Forensic Science Education in Karnataka and neighbouring states.

As a part of its mission, the University is presently offering two specialized academic programs in the niche areas of Forensic Sciences and Cyber Security, namely B.Sc.-M.Sc. Forensic Science, and B. Tech-M. Tech Computer Science & Engineering (Specialization in Cyber Security) and Professional Dipoloma in Crime Scene Management (6 months). The campus is planning to offer more programs in the coming years. NFSU Dharwad campus also intends to offer short term training programs and need based workshops for police personnel, judiciary, security officials, bankers, chartered accountants, and government officials. The vision is to develop NFSU Dharwad Campus as a "Centre of Excellence" offering education and research opportunities of very high standards in Forensics, Cybersecurity, Pharmacy & Allied Sciences.

Workshop on GeM

About GeM

Government e-Marketplace (GeM) was launched by the Government of India with the primary purpose of revolutionizing the public procurement process in the country. DGS&D with technical support of National eGovernance Division (Ministry of Electronics and Information Technology) has developed GeM portal for procurement of both Products & Services. The portal was launched on 9th August 2016 by the Commerce & Industry Minister. Procurement on GeM has been authorized by General Financial Rules (GFR) by making necessary changes in government rules.

The platform aims to bring transparency, efficiency, and cost-effectiveness to government procurement by providing a single online portal for procurement of goods and services by government departments, organizations, and public sector undertakings.

One of the key advantages of GeM is that it simplifies the procurement process for both buyers and sellers. Buyers can easily browse through a wide range of products and services, compare prices, and place orders online, thereby saving time and effort. Sellers, on the other hand, benefit from increased visibility and access to a large pool of government buyers, leading to enhanced business opportunities.

Moreover, GeM promotes fair competition among vendors, ensures compliance with government procurement rules and regulations, and reduces the scope for corruption in the procurement process. By leveraging technology, GeM facilitates faster transactions, online payment mechanisms, and delivery tracking, leading to increased efficiency and accountability in government procurement.

Presently more than 7400 products in about 150 product categories and hiring of transport service are available on GeM portal. Transactions for more than Rs 140 Crore have already been processed through GeM. GeM is a completely paperless, cashless and system driven e-market place that enables procurement of common use goods and services with minimal human interface.

About workshop on GeM

The GeM workshop is designed to offer a holistic understanding of the Government e-Marketplace (GeM), covering various aspects such as procurement methods, incident management, bid document preparation, and post-contract processes. This workshop provides participants with in-depth insights into how GeM operates, the benefits it offers, and the key procedures involved in utilizing the platform for government procurement.

In addition to the workshops, GeM authorities conduct regular training sessions both offline and online to educate stakeholders on the functionalities of the platform, best practices in procurement, and how to leverage GeM effectively for their purchasing needs. Moreover, GeM has developed a Learning Management System (LMS) tool to provide users with a self-paced learning experience, facilitating continuous education and skill development related to GeM usage and procurement practices.

These training initiatives and the availability of the GeM LMS tool demonstrate the commitment of GeM authorities to empower users with the knowledge and skills necessary to navigate the platform efficiently, comply with procurement guidelines, and optimize their interactions with the marketplace. By offering a mix of workshops, training sessions, and digital learning resources, GeM aims to enhance user proficiency, promote transparency in government procurement, and drive efficiency in the procurement process for all stakeholders involved.

Target Audience & Training Duration

The one-day GeM workshop is tailored for professionals working in the procurement section, such as officers, section officers, assistants, and clerks, providing them with insights to optimize their procurement activities. Additionally, the workshop extends its benefits to employees outside the procurement department, recognizing the value of cross-functional knowledge. Given the frequent transfers between departments, a foundational understanding of GeM can empower individuals to adapt swiftly and fulfill their duties and responsibilities effectively in various roles within the organization.
