# No turf war between three pillars of democracy: Rijiju

Gandhinagar: Union minister for law and justice Kiren Rijiju said here on Sunday



that there is no turf war between the executive, legislature and judiciary and that all three are working in the in-

terests of the nation. Rijiju said this while inaugurating the School of Law, Forensic Justice and Policy Studies at Gujarat Forensic Sciences University (GFSU).

"The judiciary, executive and legislature are different organs but all are working for the country. People outside feel there is a turf war. There is nothing like that. We all are working for the interest of the nation," said the Union minister, adding, "I have told the Chief Justice, when I became new law minister, Whenever you phone me. As the law minister of this country, I am always ready in the service of judges and judiciary. We will have to function in this manner."

Expressing contentment at the presence of many judges at the function, the minister quipped, "Today, so many judges are present here. I am really happy. At times when we face difficulties and cannot get things done politically, we place judges at the forefront. When judges are at the forefront, things get done fast. So many judges being present here is a good sign."

Commenting on the role of the government, the minister said, "In the Supreme Court, high courts and even in the lower judiciary, there are judgements or we get to listen to commentaries of judges during (court) hearings, and even anguish and satisfaction aired by them. It is our duty to implement whatever judges say," the minister said.

"There is a need for a lively relation between organs of government. In a democracy, it is very important for us to have a lively relation between us (the judiciary, executive and legislature)...It is vital for us to have a lively relationship," the minister said.

Rijiju further said the "impression" that laws are not being implemented for a long time has been removed to a great extent under the Narendra Modi government.

GANDHINAGAR: A lively relationship between the judiciary, the legislature and the executive is vital in a democracy, Union law minister Kiren Rijiju said here on Sunday even as he dismissed the perception of any turf war among these three organs. Speaking at the Gandhinagar-

based National Forensic Sciences University (NFSU) after inaugurating the new School of Law, Forensic Justice and Policy Studies, Rijiju said "it is for the government to implement whatever judges say and think and this should not be done out of fear for the contempt of court alone". "The judiciary, the executive and the legislature are separate organs, but we all work for the country. People on the outside think we are engaged in a turf war, fighting for a domain, but that is not the case. We all are working for the interest of the nation," Rijiju said.

"In the Supreme Court, high courts and even in the lower judiciary, we get to listen to commentaries of judges during (court) hearings, and even anguish and satisfaction aired by them through the media. It is for us to implement whatever judges say or think," the minister said.

Rijiju said it was for the executive to "judiciously implement" a good judgment of the court of law. "In a democracy, it is very important for us to have a lively relation between us (the judiciary, executive and legislature)...It is vital for us to have a lively relationship," he said.

THERE IS no "turf war" between the judiciary, legislature and executive in the country, said Union Minister of Law and Justice Kiren Rijiju on Sunday, adding that the central government was willing to work hard to earn judges' praises.

"The judiciary, executive and legislature are different organs, but we work together for the country. At times, people from outside think there is a turf war or fight going on over the domain... There's nothing like that. We are all working for the interest of the nation," the minister said at the inauguration of the School of Law, Forensic Justice and Policy Studies at the National Forensic Sciences University (NFSU) Gandhinagar.

"Whenever we are in trouble or we are not able to do our job as politicians, we bring judges forward. Work gets done easier when judges are at the front... When I was appointed the law and justice minister, I told the Chief Justice of India that whenever you call me as a law minister.

of the country, I amalways ready for the services of the judges and the judiciary. Whenever we see an issue in the Supreme Court, high court or lower courts, there are times we are able to listen to the commentary during hearing or judgements," Rijiju said.

Saying that fear for contempt of court should not be the only reason behind implementing good judgements, the minister added, "In the legislature, whenever we make laws on paper, we are also frustrated that they are not implemented swiftly. But now due to the visionary leadership of PM Modi, that environment is long gone. The word aaram (relaxation) is no longer

in our dictionary."

"If we all work proactively, then the judiciary will also not taunt us and they will also appreciate the government's work. Judges will say good about us only when we do good. I assure all the judges here that our government will work with all our heart and with transparency." Rijiju said at the event where Guiarat Chief Minister Bhupendra Patel, Minister of State for Home Harsh Sanghavi, SC judge Justice MR Shah, acting Chief Justice of Gujarat High Court Justice RM Chhaya and Gujarat Law and justice minister Raiendra Trivedi were also present.

The Gandhinagar-based

NFSU will offer two programmes — a five-year integrated BSC plus LLB Honours course (post Class 12) and a three-year LLB Honours course (post-graduation) under the newly inaugurated School of Law, Forensic Justice and Policy Studies.

Speaking at the event, CM Bhupendra Patel said the school will provide techno-legal experts who will be equipped with state-of-the-art technology. "As the nature of crime has changed, it will enable the justice delivery system to tackle the current challenges with the help of forensic sciences and also facilitate to provide evidence in

courts. It will also offer employment opportunities to the youth," he said.

NFSU Gandhinagar Vice-Chancellor Dr JMVyas said, "We are following the vision of PM Modi... we started with five courses, and today we have over 70 courses. We are also opening our campuses and training centres in different states of the country. Forensic sciences play an extremely crucial role in the criminal justice delivery system and in that regard, our university is attempting to cover the three aspects of this system which include legal aspect, forensic sciences and policing and security."
