Details of educational qualifications and experience for contractual appointments are as under:

1. Assistant Professor (Forensic Psychology)

Upper Age Limit – 40 years

Qualification – M.Sc./ M.Phil. in Forensic Psychology with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) from an Indian University or an equivalent degree from an accredited Foreign University.

Besides, the candidate must have cleared the National Eligibility Test (NET) conducted by UGC or the CISR, or a similar test conducted by UGC, like SLET/SET. Who are or who have been awarded a Ph.D degree in accordance with the UGC (Minimum Standards and Procedure for Award of M.Phil/Ph.D degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be are exempted from NET/SLET/SET.

Provided the candidates registered for Ph.D programme prior to July11, 2009 shall be governed by the then existing ordinances/bye-laws/regulations of the institutions awarding the Degree and such Ph.D candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions subject to the fulfillment of the following conditions.

- (a) The Ph.D degree of the candidate is awarded in the regular mode.
- (b) The Ph.D thesis has been evaluated by at least two external examiners.
- (c) An open Ph.D viva voce of the candidate has been conducted.
- (d) The candidate has published two research papers from his/her Ph.D work. Out of which at least one is in refereed journal.
- (e) The candidate has presented at least two research papers based on from his/her Ph.D work in conferences/seminars sponsored /funded/ supported by UGC/ICSSR/CSIR or any similar agency.

The fulfillment of the above conditions is to be certified by Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

GENERAL INSTRUCTIONS AND GUIDELINES:

1. Employment of the University shall be governed by the Rules and Regulations, by Laws and service conditions, as may be notified by the University from time to time;
2. The crucial date for determining the age limit shall be the closing date for receipt of applications;
3. Mere fulfillment of eligibility criteria shall not necessarily entitle an applicant to be called for test/interview. The University reserves the right to relax any of conditions and shortlist the applicants in a manner as it may specify;
4. Relaxation in marks shall be permissible to SC/ST candidates as per Government of India rules/guidelines.

5. Last date for the submission of scanned copies of the application form will be 20 Jan 2021. Interviews for the Posts mentioned in Sr No. 1 will be conducted within a week thereafter.

6. After the scrutiny of applications, all the eligible candidates will be informed to appear for the interviews.

7. No TA/DA shall be payable to applicant for any journey performed for attending the test/interview.

8. The University reserves the right of not filling any advertised post(s) without assigning any reason.
9. The University reserves the right to increase or decrease the number of posts to be filled-up.
