3. Interview Schedule:
  - a. **13<sup>th</sup> December 2022 at 10:00 a.m.** onwards at the National Forensic Sciences University, Sector-9, Gandhinagar (Gujarat)
    - i. *For candidates exempted from test*
    - ii. *For candidates who qualify in University Entrance Test by scoring minimum 50% of marks*

- b. **14<sup>th</sup> December 2022 at 10:00 a.m.** onwards at the National Forensic Sciences University, Sector-9, Gandhinagar (Gujarat)
  - i. ***For Professional Category candidates.***

The professional category includes persons working in Public Sector Undertaking/ Government Department/ National Laboratories/ Research Development Organization/ Private Industry / Educational Institution/Fellow Members of Institute of Chartered Accountants/ experienced Company Secretaries, with a recognized Master degree with 60% marks and a minimum relevant experience of 10 years. Such candidates may be considered by the interview committee under this category as a full time sponsored candidate subject to receipt of financial support from their sponsoring organization .

4. **The candidates who have qualified at the UGC NET/ JRF, UGC CSIR NET/GATE/CEED/DST INSPIRE/ICMT and similar National level Test are exempted from the Entrance Test and may appear directly in interview if they have a valid score and documentary proof of their eligibility.**
5. The candidates must ensure their eligibility as per prescribed rules before appearing for Entrance Test and /or Interview. The candidates found to be making false/unsupported claims will be rejected summarily.
6. The candidates who qualify for interview must bring with them Application form , Application form fees receipt and self-attested copies of their, educational qualifications, valid caste certificate issued by the competent authority for claims of reservation, experience certificates, statements of marks and of the S.S.C. or equivalent certificate in support of their date of birth.
7. The allocation of seats shall be reserved as per Government of India guidelines.

8. Candidates who have qualified for Junior Research Fellowship should submit a copy of the relevant letter or certificate from University Grants Commission.
9. Candidates who are employed should submit their applications through proper channel, along with a No Objection Certificate from the employer.
10. Appearing for test and/or interview will not ensure admission to a Ph.D. Program. The final decision for admission will be with the interview committee on the basis of educational qualifications, experience, performance in interview/presentation and field of interest.
