

GENERAL INSTRUCTIONS

- 1. The prescribed qualifications and/or experience shall be the minimum, and the mere fact that a candidate possesses the same shall not entitle him/her to an interview. National Forensic Sciences University shall have the right to restrict the number of candidates to be interviewed to a reasonable level based on better or higher qualifications and experience than the minimum prescribed.
- 2. The contractual appointment shall end on the contract's stipulated expiry date in the appointment letter. Selected candidates shall have no right to renewal or extension of conversion into permanent employment.
- 3. The University retains the discretion not to make any appointment to this vacancy, to make an appointment at a revised remuneration, or to make an appointment with a modified job description and to fix revised qualification, experience, remuneration and requirements.
- 4. Canvassing or influencing in any form on behalf of any candidate will disqualify such candidate. National Forensic Sciences University reserves the right to take appropriate action against such a candidate.
- 5. Read carefully qualification & experience for the requirements of the relevant discipline and apply only if you have requisite qualifications and experience.
- Shortlisted candidates will be informed by email(apart from the website) about the interview date. The candidate must provide valid e-mail IDs in the application.
- 7. Applicants for employment (private, government, or any other organization) are required to submit a No Objection Certificate (NOC) from their employer along with their CV and other relevant certificates/Credentials when submitting their applications
- 8. In case of any inadvertent mistake in the selection process, which may come to notice at any stage even after the issue of an appointment letter, the National Forensic Sciences University reserves the right to modify/withdraw/cancel any communication or offer made to the candidates at any stage.
- 9. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the National Forensic Sciences University shall be final and binding.
