National Forensic Sciences University, Dharwad Campus invites Expression of Interests (EOI) from the medical practitioners as Part Time Visiting Consultant Doctor (General Physician), on hourly paid and temporary retainer-ship basis, for NFSU Dharwad Campus for providing consultation services in the campus to the Students, Faculty & Staff of NFSU Dharwad Campus.

#### **ESSENTIAL QUALIFICATION & CRITERIA: -**

- **Educational Qualification:** The candidate must possess an MBBS degree from a recognized university or equivalent qualification, duly recognized by the Medical Council of India (MCI).
- Experience:
  - a) A minimum of ten (10) years of professional experience in medical practice is mandatory. Experience in handling medical claims shall be considered essential.
  - b) Preference shall be extended to practitioners currently empanelled with Public Sector Undertakings (PSUs), Autonomous Bodies, or Educational Institutions for similar assignments.
- **Registration:** The candidate must hold a valid registration with the Medical Council of India and be duly registered with the Karnataka Medical Council.
- **Retired Medical Practitioners:** Retired government/PSU doctors fulfilling the above criteria are also encouraged to apply.

#### **TERMS AND CONDITIONS:**

1. The empanelled medical consultants shall be **required to visit the NFSU**, **Dharwad Campus**, as per the scheduled frequency mentioned below:

Sr. No	Particulars	Frequency
01	Doctor (Male)	3 days in a week
02	Doctor (Female)	1 day in a week preferably Saturday or Sunday

- 2. The engagement shall be **purely temporary** and on a **consultancy basis**, and no claim for regular appointment or absorption into any **permanent or sanctioned post** at NFSU Dharwad Campus shall be entertained.
- 3. The NFSU, Dharwad Campus, reserves the right to reject any or all EOIs without assigning any reason thereof. No correspondence in this regard shall be entertained.
- 4. The university also reserves the right to **terminate the services** of the consultant **at any point in time**, without assigning any reason, in case the performance is found to be unsatisfactory.
- 5. The contract is terminable by either side by giving one months' notice in writing. No reasons would be assigned for such terminations.
- 6. No other allowances, benefits, or facilities shall be admissible apart from the approved remuneration per visit.
- 7. All consultations and records shall be **maintained confidentially**, and the data collected in the course of consultations shall not be disclosed to any unauthorized person or agency.

#### **SCOPE OF WORK & RESPONSIBILITIES:**

The empanelled medical consultants shall be required to:

- Function as **Authorized Medical Attendants** of NFSU Dharwad Campus and issue appropriate prescriptions to all individuals seeking medical advice.
- Attend to medical cases of employees on **commuted leave** and provide necessary medical certificates thereof.
- Examine and **verify medical claims and bills** submitted for OPD/IPD reimbursements.
- Regularly **review the medical health status** of students and staff and maintain appropriate documentation.
- Advise on **preventive health measures** and assist in health awareness programs organized at the Wellness Centre.
- Be available for **emergency medical consultation**, if required, during their scheduled visits.

#### APPOINTMENT & TENURE: -

- The appointment shall be made on a temporary and hourly-paid basis for an initial period of one (1) year, which may be extended up to a maximum of three (3) years, including the first year.
- **Continuation beyond each year** shall be contingent upon **satisfactory performance**, as evaluated by a competent authority.

#### **DOCUMENTS REQUIRED FOR SUBMISSION:**

Applicants must submit the following documents along with the EOI:

- Updated Curriculum Vitae (CV) with a recent passport-size photograph
- Self-attested copies of educational qualifications and registration certificates
- Proof of relevant experience, especially in handling medical claims
- Copy of Aadhaar Card and PAN Card
- Quotation per visit to be submitted in online form

#### **SELECTION PROCEDURE:**

- The EOIs received shall be **scrutinized by a duly constituted committee**, considering the educational qualifications, relevant experience, and quoted consultation fee.
- Shortlisted candidates may be called for **interaction/interview**, if deemed necessary.
