# MINIMUM ELIGIBILITY REQUIREMENTS FOR ASSISTANT PROFESSOR (CONTRACTUAL)

#### Qualifications:

- A good academic record in different level examinations in the career.
- 2. A Master's degree with at least 60% marks (or equivalent grade on a point scale the grading system is wherever followed) with Ph.D in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited Foreign University.

The maximum age limit for general category candidates is 50 years. 5 years relaxation will be given for reserved category candidates.

In case, qualified & suitable candidates are not found for the Assistant Professor position in any of the disciplines, the University may appoint a contractual faculty member at lower remunerations either as an Assistant Professor or as lecturer with the following Terms & Conditions:

- (a) Candidates having Master degree with minimum first class or atleast 60% or equivalent in relevant discipline from recognized university with very good academic record throughout and qualified NET Exam in relevant branch shall be considered for the post of Assistant Professor (Contractual).
- (b) Candidates having minimum qualifying degree i.e. Master Degree with minimum first class or at least 60% or equivalent at Master's Level in relevant discipline from recognized university with very good academic record throughout shall be considered for the post of Lecturer (Contractual).

#### Consolidated remuneration:

- a. Assistant Professor (Regular Remuneration): Candidates having Ph.D. degree in relevant discipline with minimum first class or at least 60% or equivalent at the preceding degree in relevant discipline from recognised, university with very good academic record throughout shall be considered for the post of Assistant Professor (contractual) and will be paid consolidated remuneration of Rs. 90,000/- per month.
- b. Assistant Professor (Lower Remuneration): Candidates having Master degree with minimum first class or at least 60% or equivalent in relevant discipline from recognised university with very good academic record throughout and qualified NET exam in relevant branch shall be considered for the post of Assistant Professor (contractual) and will be paid consolidated remuneration of Rs. 75,000/- per month.
- c. Assistant Professor I Lecturer (Lower Remuneration): In case the NET exam is not conducted by UGC in the particular desired subject, then the candidates having Master Degree with minimum first class or at least 60% or equivalent at Masters level in relevant discipline from recognised university with very good academic record throughout shall be considered for the post of Assistant Professor (contractual) and will be paid consolidated remuneration of Rs.68,000/- per month and candidates having minimum qualifying degree, i.e., Master Degree with minimum first class or 60% or equivalent at Masters level in relevant discipline from recognised university with very good academic record throughout shall be considered for the post of lecturer, contractual and will be paid consolidated, remuneration of Rs. 68,000/- per month. The preference shall be given to the candidate who is pursuing their Ph.D. from any INI or recognized university.

### IMPORTANT INFORMATION

- Candidates appearing for interview may be considered for lower post if they are otherwise found suitable.
- 2. The university may conduct a screening test before the interview on the same day or one day prior to the interview date, if the number of applications are more.


