- 1- We shall follow the admission calendar to offer admission to different programs at NFSU School of Law.
- 2- For knowing your Merit List, you may go to the “admission application portal” (admission.nfsu.ac.in) and LOG IN with your own relevant LogIn ID and Password.
- 3- Once you are logged in to your account, you would be able to see the NFSU RANK in General Category as well as in Reserved Category (if applicable).
- 4- As per the merit list and in accordance to the seats available; qualified applicants would be receiving an invitation email for ONLINE COUNSELING, where attendance is MANDATORY if you wish to secure admission to SLFJPS, NFSU for the academic year 2024-25.
- 5- If you fail to attend the ONLINE ADMISSION COUNSELING on the designated date and time, you SHALL be marked absent and it SHALL be presumed that, you have relinquished your right to claim admission and the said seat shall be offered to the next person in MERIT.
- 6- Once, the admission counseling is done, those who are present and wish to take admission shall receive a PAYMENT link and GR Number for completion of their admission process on the APPLICATION PORTAL (where you got your Merit List).
- 7- Complete the process of Payment and Keep copy of the GR number for future process.
- 8- After reconciliation at the University level, you shall receive the Fee Receipt on the Portal.
- 9- For further process afterwards, do follow the admission Calendar given above.
