- 2. Bring a printed copy (first page only) of your admission application form and any one identity card (issued by Government) for getting entry to the exam hall. (No separate admit cards will be issued).

3. Interview Schedule:

- a) 25th and 26th July 2023 at 10:00 A.M. onward at the National Forensic Sciences University, Sector-9, Gandhinagar (Gujarat)
 - For candidates exempted from entrance test. (Professional Category and NET/GATE/GPAT/other national or state level exam qualified)
 - For candidates who qualify in University Entrance Test by scoring minimum ii.
- 4. For professional category candidates:

The professional category includes persons working in public sector undertaking/Government Department/ National laboratories/ Research development organization/Private industry/Educational institution/Fellow members of institute of CharteredAccountant experiencedCompany Secretaries, with a recognized Master degree with 60% marks and a minimum relevant experience of 10 years.

- 5. The candidates who have qualified at the UGC NET/JRF, UGC CSIR NET/GATE/CEED/DSTINSPIRE/ICMT and similar National level Test are exempted from the entrance test and may appear directly in interview if they have a valid score and documentary
- 6. The candidates must ensure their eligibility as per prescribed rules before appearing for Entrance Test and/or Interview. The candidates found to be making false/unsupported claims
- 7. The candidates who qualify for interview must bring with them Application form, self-attested copies of their educational qualification certificates, valid cast certificate issued by the

competent authority for claims of reservation, experience certificates, statements of marks and of the S.S.C. or equivalent certificate in support of their date of birth.

- 8. The allocation of seats shall be reserved as per Government of India guidelines.
- 9. Candidates, who are employed in any organization, need to produce a No Objection Certificate (NOC) from the employer for their admission if they are selected through interview.
- 10. Appearing for the test and/or interview will not ensure admission to the PhD Program. The final decision for admission will be with the interview committee on the basis of your performance in interview.
