1. The Experience and Qualification will be reckoned on the last date of submission of the Application.
2. Applicants are advised to submit the documents related to their Change of Name (if applicable) (i.e., Marriage Certificate, Gazette for Name Change, Aadhar Card) at the time of screening.
3. The University reserves the right to fill or not to fill any or all the posts, without assigning any reason and no notice will be issued in this regard.
4. The University shall verify the antecedents and documents submitted by candidates at any time, at the time of appointment. In case it is detected any time, even during the service, that the documents submitted by the candidates are fake or the candidates have undesirable clandestine antecedents/background and have suppressed the said information, his / her services shall be liable to be terminated.
5. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issuance of the appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
