- The candidate must be a citizen of India. 1.
- The Project Execution Committee (PEC) reserves the right to increase or 2. decrease the positions and fill or not to fill positions in any of the above and/or any other specialization(s).
- The prescribed essential qualifications/experience indicated is bare minimum 3. which is required for the role. Mere possession of these qualifications/experience will not entitle the candidate(s) to avail the position.
- The University / PEC shall verify the antecedents and documents submitted by 4. candidates at any time, at the time of appointment, or during the tenure of service.
