In case the candidates who do not possess Ph.D. Degree but are pursuing Ph.D in relevant disciplines at any INI or reputed University / Institute, and have good academic record throughout may be considered for contractual appointment as Teaching & Research Assistant (TRA). In case of non availability Ph.D awarded/Ph.D. enrolled candidates, professional degree holders like CA or first class Master Degree holders in relevant discipline can be considered for temporary contractual appointment as Visiting Faculty.

1. Candidate has to appear for interviews on **24th August 2022** at 11.am. along with all original documents of educational qualifications.
2. The posts listed above are temporary positions on contractual basis for **11 months** or till the recruitment for regular faculty members are done or whichever is earlier.
3. Candidate should bring one set of certified documents (degree/mark sheet/experience certificate, etc) at the time of Interview.
4. The original certificate(s) must be shown at the time of interview.
5. In-service candidates must bring NOC at the time of interview from their employer.
6. The University reserves the right to increase or decrease the positions and fill or not to fill positions in any of the above and/or any other specialization(s).
7. Fixed/Consolidated remuneration for the posts advertised shall be paid as per the norms of NFSU.
