The preference shall be given to the candidates, who are pursuing their PhD from any INI or recognized university

16. Candidates, who have obtained degrees or diplomas or certificates for various courses from any Institution declared fake/derecognized by the University Grants Commission, New Delhi shall not be eligible for being considered for recruitment to the posts advertised.
