

**Qualifications**: Ph.D in the appropriate branch with first class at the preceding Master degree or equivalent in the appropriate branch with a very good academic record throughout. (Discipline-wise qualification is given in the table below). The candidate who has given the viva voce for the award of Ph.D. may also apply.

In case the candidates who do not possess Ph.D. Degree but are pursuing Ph.D in Forensic science or its allied branches or other relevant disciplines at any INI or reputed University / Institute, and have good academic record throughout may be considered for contractual appointment as Teaching & Research Assistant (TRA). The consolidated remuneration will be paid to all contractual staff as per the norms of NFSU.

Candidates, in addition to first class master degree possess additional diploma or degree in specific subject from recognised university/institute, even they don't possess PhD degree or not registered for PhD can be considered for the temporary post of lecturer /visiting faculty.

### **Additional Information**

- 1. Candidates need to bring hard copy of filled in application (in given format only) along with all relevant documents of educational qualifications.
- 2. Candidate should attach one set of self-certified documents (degree/mark sheet/experience certificate, etc) at the time of Interview.
- 3. All the original certificate(s) must be shown to the selection committee at the time of interview.
- 4. The posts listed above are temporary positions on contractual basis for <u>11 months</u> or till the recruitment for regular assistant professors are done or whichever is earlier.
- 5. In Service candidates, shall have to submit relieving order from their earlier employer at the time of joining if he/she is selected at NFSU.
- 6. The University reserves the right to increase or decrease the positions and fill or not to fill positions in any of the above and/or any other specialization(s).
- 7. No correspondence, whatsoever, will be entertained from candidates regarding, conduct and result of interview and reasons for not being called for interview or selection.
- 8. All qualifications must be from UGC recognized University/Deemed University or RCI/BCI/PCI/AICTE approved autonomous institution (wherever applicable). The courses offered by autonomous institutions should be equivalent to the relevant course approved/recognized by Association of Indian University (AIU).
- 9. Candidates called for interview to fill a vacancy, may be considered for lower post if they are otherwise found suitable.
- 10. If found that the candidate is not progressing as desired, the University has the complete authority to expel the appointee at any time.
