# SUB: ANNOUNCEMENT OF INTERNSHIP PROGRAM AT Center-FTF -2024

Internship program in Food Forensics at the Centre of Food Technology and Forensics, National Forensic Sciences University, Gandhinagar Campus will commence from 27st May, 2024 till 26th June, 2024 (30 days). Applications are invited from eligible students of India.

# Eligibility and selection criteria will be as follows:

- Students who are pursuing final year of graduation or post-graduation.
  Only Students of regular courses of UGC Recognized Universities will be
  eligible.
- Students must have attained a minimum of 60% marks in Class XII and all subsequent semester examinations of UG/PG Programs.
- Admission/intake in internship is based on 75% merit (in the preceding degree/average marks in case of 2<sup>nd</sup> /3<sup>rd</sup> / 4<sup>th</sup> Semester) and 25% performance in online interview.

#### **Brief Course Structure:**

Approximately 10 sessions on various issues concerning forensics, Food Forensics will be covered to sensitize the interns. The internship will include the following inputs as per feasibility of lab facility:

- Group discussion and classroom sessions
- Research/ project work on areas surrounding food forensics
- Paper review presentations
