- 4. Matriculation/Higher Secondary/UG/ PG Certificate and Mark sheets are to be submitted.
- 5. Essential Qualification (s) i.e. Bachelor's Degree/ Degree Certificate from a recognized University or equivalent (obtained before the last date for submission of online application date (i.e.) 21/05/2022 mentioned in the Notice for the Recruitment) along with Consolidated Mark Sheet and Year-wise Mark Sheets (with overleaf details, if any) in proof of subjects studied at various levels;
- 6. It is reiterated that the result of required educational qualification must have been declared by the Institute/ University by the specified date. Mere processing of the result by the University/ Institute by the last date for submission of online application i.e. 21/05/2022, does not fulfill the EQ requirement.
- 7. SC/ST/OBC-NCL/EWS/PwBD/ESM Certificates obtained within the stipulated period from competent authorities, in the prescribed format as applicable;

Note: A person seeking appointment on the basis of reservation to OBC-NCL/ EWS must ensure that he/she possesses the caste/ community certificate. Candidates claiming to belong to OBC category must ensure that they do not fall in creamy layer on the last date for submission of online application date. The last date for submission of online application date for this purpose will be the closing date for receipt of online application i.e. 21/05/2022.


Affidavit from husband and wife along with a joint photograph duly sworn before the Oath Commissioner;

- (ii) In case of re-marriage of women: Divorce Deed/ Death certificate as the case may be in respect of first spouse; and photocopy of present husband's passport showing names of spouse or an attested copy of marriage certificate issued by the Registrar of Marriage or an Affidavit from the husband and wife along with joint photograph duly sworn before the oath Commissioner.
- (iii) In case of divorce of women: Certified copy of Divorce Decree and Deed Poll/ Affidavit duly sworn before the Oath Commissioner.
- (iv) In other circumstances for change of name for both male and female: Deed Poll/ Affidavit duly sworn before the Oath Commissioner and paper cuttings of two leading daily newspapers in original (One daily newspaper should be of the area of applicant's permanent and present address or nearby area) and Gazette Notification.
- 12. You have to appear for the document verification at your own expenses.
- 13. Your candidature is Provisional. You must, therefore, ensure that you fulfil all the conditions of eligibility laid down in the advertisement. If, at any stage, it is found that you do not fulfill any of the conditions of eligibility, your candidature will be cancelled and no appeal against such cancellation will be entertained.
- 14. The fact that you have been called for Document Verification does not confer any right on you to be treated as eligible in all aspects for appointment.
