

- 11. The candidate has to produce one set of self-certified documents (degree/mark sheet/experience certificate, etc.) at the time of the Interview.
- 12. All the original certificate(s) must be shown to the Selection Committee if selected for the post.

- 14. The candidates selected can be posted at NFSU, Gandhinagar, Gujarat Campus or any other campus(es) of NFSU as per the requirement of the project.
- 15. Upon selection, the candidates will be required to produce a notarized Undertaking and Non-Disclosure Agreement with the department.
- 16.In-service candidates, have to submit a relieving order from their earlier employer at the time of joining, if he / she is selected for the Project.
- 17. The NFSU-PMU reserves the right to increase or decrease the positions and fill or not to fill positions in any of the above and/or any other specialization(s).
- 18. All qualifications must be from UGC recognized University / Deemed university / AICTE approved Autonomous Institution (wherever applicable). The courses offered by Autonomous Institutions should be equivalent to the relevant course approved/ recognized by the Association of Indian University (AIU).
- 19. Qualifications are relaxable at the discretion of the NFSU-PMU members for a reason to be recorded in writing in case of candidates otherwise well qualified.
