#### TERMS & CONDITIONS:

i) **Remuneration:** Remuneration will only be consolidated as per conditions given below:



a) Candidates having Ph.D. degree in relevant discipline with minimum First class (60% or equivalent) at the preceding degree in relevant discipline from recognised university with very good academy record throughout shall be considered for the post of Assistant Professor (Contractual) and will be paid Rs. 90,000 per month.

b) In case, qualified & suitable candidate does not found for the Assistant Professor position in any of the disciplines, the university may appoint contractual faculty member at lower remuneration either as Assistant Professor or as a Lecturer. The details of the same are as under:

1. Candidates having Master degree with minimum first class or 60% or equivalent in relevant discipline from recognised university with very good academic record throughout and qualified NET Exam in relevant branch shall be considered for the post of Assistant Professor (Contractual) and will be paid consolidated remuneration of Rs. 75000/- per month.

2. In case the NET exam is not conducted by UGC in the particular desired subject, then the candidates having master degree with minimum first class or 60% or equivalent at masters' level in the relevant discipline from recognized university with very good academic record throughout shall be considered for the post of Assistant Professor (Contractual) and will be paid consolidated remuneration of Rs. 68000/- per month.

3. Candidates having minimum qualifying degree i.e. master degree with minimum first class or 60% or equivalent at master's level in relevant discipline from recognised university with very good academic record throughout shall be considered for the post of Lecturer (contractual) and will be paid consolidated remuneration of Rs. 68000/- per month. The preference shall be given to the candidates, who are pursuing their Ph.D. from any INI or recognised university.

4. The filling up of the above posts shall be on need basis and purely temporary and contractual.

5. The engagement of the candidates in these posts does not confer any right or title to claim a permanent appointment at this University.

6. The posts listed above are temporary positions on contractual basis for a period of 11 months but extendable on the basis of performance, requirement or till the recruitment of regular incumbent is done or whichever is earlier.

7. The University reserves the right to fill or not to fill any or all the advertised posts, without assigning any reason and no notice will be issued in this regard.

8. The University reserves the right to accept or reject any application without assigning any reason.

9. The University shall verify the antecedents and documents submitted by candidates at the time of appointment. In case it is detected at any time, even during the service, that the document(s) submitted by the candidates is (are) fake or the candidate has clandestine antecedent background and have suppressed, the said information, his/ her services shall be liable to be terminated.

10. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issuance of the appointment letter, the university reserves the right to modify/ withdraw/ cancel the candidature and even without any communication made to the candidates.

11. Canvassing in any form and/or bringing in any political influence or otherwise will be treated as a disqualification criteria for the post



12. This recruitment shall be made in compliance with Reservation Policy of Government of India.
13. Notwithstanding anything contained herein, the University reserves the right to:
- Offer the post at a level lower than that advertised depending upon the qualifications, experience, and performance of the candidates, by relaxing any of the requirements:
  - draw reserve panel (s) against the possible vacancies in the future.
  - Consider "in- absentia" the candidature of those who may or may not have applied, or may have applied for higher positions.
  - Relax any of the qualifications/ experience at its discretion and not to fill-up any or all of the advertised positions.
14. The NFSU Manipur Campus reserves the right:
- To withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect.
  - To fill or not to fill up some or all the posts advertised for any reason whatsoever.
  - To increase/ decrease the number of posts after the due procedure.
  - To conduct the online interview based on candidates request subject to approval of the competent authority.
15. The NFSU Manipur campus will not be responsible for any loss of any communication due to the wrong address/email id provided by the candidates.
16. In case of any dispute/ ambiguity that may occur in the process of selection, the decision of the University in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, the conduct of examination/interview will be final and no query or correspondence will be entertained in this connection from any individual or his/ her agency.
17. No person shall be recruited unless he/she is in mentally sound and physically fit and free from any physical defect that is likely to interfere with the efficient performance of his/ her official duties. If selected and appointed, he/she shall be required to produce a medical fitness certificate on or before the date of joining.
18. The terms and conditions of appointment shall be communicated in the form of an "Offer of Appointment" to the selected candidates. If the candidate does not accept the terms and conditions mentioned in the offer of appointment within the stipulated time, the offer shall be treated as withdrawn.
19. In case of any dispute, suit, or legal proceeding against the NFSU Manipur Campus, the jurisdiction shall be restricted to the Hon'ble High Court of Manipur.

**3. The last date for receiving application is 02-09-2024.**

4. Application fees in INR 500 must be submitted along with application in the form of crossed DD in favour of Institute of Forensic Sciences for Training and Skilling, NFSU Manipur, payable at Imphal.

5. Candidates are advised to visit the website of NFSU (<https://www.nfsu.ac.in/career>) regularly for any updates/ amendments/ corrigendum related to this advertisement.

6. The candidates will be shortlisted based on eligibility criteria and the list with schedule of interview will be placed on NFSU website. The candidates will also be intimated through their email.

7. Depending on the number of candidates for the post, interview(s) may go till late in the day or may require to be conducted on the subsequent day. The candidates are required to make their arrangement accordingly.

8. The qualifications prescribed should have been obtained through recognised Universities or institutions.

9. The prescribe Essential Qualifications are a bare minimum and mere possession of it, will not entitle the candidate to be considered for the post. The candidates should furnish all the Qualifications and Experience possessed in the relevant field, or and above the minimum qualifications prescribe for consideration their candidature.

10. In case the candidates who do not possess Ph.D. Degree but are pursuing Ph.D. in Forensic Science or its allied branches or other relevant disciplines at any INI or reputed University/ Institute, or NET qualified in the relevant subject and have good academic record throughout may be considered.

11. Applicants are advised to submit the documents related to their change of Name (if applicable) ( i.e. Marriage certificate, Gazette for Name Change , Aadhar Card).

12. Wherever grading or any other system that the percentage is followed, the result of the candidate should be converted into a percentage on the basis of the percentage conversion table declared by the concerned university.

13. Candidates, who have obtained degrees or diplomas or certificates for various courses from any institution declared fake/derecognised by the University Grant Commission, New Delhi shall not be eligible for being considered for recruitment to the posts advertised.

14. The medium of instruction in respect of all courses conducted in the School, Centres and Department, admitted to the privileges of the University shall be English.

15. The Candidate will be required to produce the original documents relating to educational qualifications, experience, and other essential requirements, etc. in original at the time of the interview, ailing which, his candidature stands cancelled.

16. Candidate in service of "Government / Semi-Government/ PSUs should have obtained NOC from his/ her employer may be submitted at the time of interview.

17. All documents to be submitted by the candidates should be serially numbered and indexed.
