MINIMUM ELIGIBILITY REQUIREMENTS FOR ASSISTANT PROFESSOR (CONTRACTUAL)

Qualifications :

- A good academic record
- A Master's degree with 60% marks (or equivalent grade on a point scale wherever the grading system is followed) with Ph.D in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited Foreign University.

In case, qualified & suitable candidates are not found for the Assistant Professor position in any of the disciplines, the University may appoint a contractual faculty member at lower remunerations either as an Assistant Professor or as lecturer with the following Terms & Conditions:

- (a) Candidates having Master degree with minimum first class or 60% or equivalent in relevant discipline from recognized university with very good academic record throughout and qualified NET Exam in relevant branch shall be conserved for the post of Assistant Professor (contractual).

(b) Candidates having minimum qualifying degree i.e Master Degree with minimum first class or 60% or equivalent at Master's Level in relevant discipline from recognized university with very good academic record throughout shall be considered for the post of Lecturer (Contractual).

Consolidated remuneration :

- a. **Assistant professor (Regular remuneration)** : *Candidates having Ph.D. degree in relevant discipline with minimum first class, or 60% or equivalent at the preceding degree in relevant discipline from recognised university with very good academic record throughout shall be considered for the post of assistant professor contractual, and will be paid consolidated remuneration of Rs. 90,000/- per month*
- b. **Assistant Professor (Lower Remuneration)** : *Candidates having Master degree with minimum first class or 60% on equivalent in relevant discipline from recognised university with very good academic record throughout and qualified NET exam in relevant branch shall be considered for the post of assistant professor contractual and will be paid consolidated remuneration of Rs.75,000/- per month.*
- c. **Assistant professor /lecturer (lower remuneration)** : *In case the NET exam is not conducted by UGC in the particular desired subject, then the candidates having master degree with minimum first class or 60% are equivalent at Masters level in relevant discipline from recognised university with very good academic record throughout shall be considered for the post of Assistant professor contractual and will be paid consolidated remuneration of Rs.68,000/- per month and Candidates having minimum qualifying degree, i.e, master degree with minimum first class, or 60% or equivalent at Masters level in relevant discipline from recognised university with very good academic record throughout shall be considered for the post of lecturer, contractual and will be paid consolidated, remuneration of Rs. 68,000/-per month. The preference shall be given to the candidate who are pursuing their Ph.D. from any INI or recognised university.*

IMPORTANT INFORMATION

1. Candidates appeared for interview may be considered for lower post if they are otherwise found suitable.
2. The university may conduct screening test before the interview on the same day or one day prior to interview date, if the number of applications are more.
3. The university reserves the right to place the candidate after selection in any of the university campus where the subject specific vacancy exists.
4. Contractual appointment will be for Eleven months only.
5. It is the responsibility of the candidate to ensure his/her eligibility for the post before appearing for the Interview.
6. Candidate will be only allowed to appear before the interview panel, subject to his/he eligibility.

7. Depending on the number of candidates for the post, interviews may go till late in the day or may require to be conducted on the subsequent day. The candidates are required to make their arrangement accordingly.

Eligible candidates will be called for walk in interview. In this regard (Eligibility) decision of the Competent Authority is Final. The information in this regard will be placed on the university website & also will be forwarded to the candidates registered email.

4. Mere fulfilment of the above mentioned qualifications and experience does not entitle a candidate to be called for interview.
5. University reserves the right to increase or decrease the positions and fill or not to fill positions in any of the above /and or any other specialization(s).

7. No TA/DA will be paid for attending the interview.

The courses offered by autonomous institutions should be equivalent to the relevant course approved, recognised by Association of Indian University (AIU).

Other terms and conditions :

- a. The post listed above are temporary positions and on contractual basis for 11 months or till the recruitment for the position is filled against the regular vacancy, or whichever is earlier.
- b. One set of self - certified documents (degree /marksheet /experience certificates etc) Should be submitted to the recruitment cell at the time of the interview.
- c. The original certificates must be shown at the time of the interview.
- d. If found ineligible the university is liable to terminate the contract at any time.
- e. Applicable fees is INR Rs 500/- (Rupees Five Hundred only) which must be submitted along with application in the form of crossed DD in favour of the Campus Director,NFSU Tripura campus, payable at Agartala.
- f. Those who are in employment are required to submit a no-objection certificate from their employer.
