The candidate should have demonstrated leadership in research in a specific area of specialization in terms of guidance of Masters and Ph.D. students, good record of sponsored research, publications in reputed journals and referred conferences, patents, laboratory/ course development and/ or other recognized relevant professional activities faculty members are expected to teach courses, carry out research, design and engage in university development and conduct training program and consultancy.

### MINIMUM ELIGIBILITY REQUIREMENTS FOR ASSISTANT PROFESSOR (CONTRACTUAL)

Qualifications: Ph.D. in the appropriate branch with first class at the preceding degree or equivalent in the appropriate branch with a very good academic record throughout. The candidate who has given the viva voce for the award of Ph.D. may also apply.

Remuneration for Asst Professor: Consolidated fixed monthly remuneration of Rs.90,000/- only.

In case the candidates who do not possess Ph.D. Degree but are pursuing Ph.D. in Forensic science or its allied branches with more than two year research experience at any INI or reputed University / Institute, and having good academic record may also be considered for contractual appointment as Teaching & Research Assistant (TRA).
