

#### **General Instructions:**

- 1. The prescribed qualifications and/or experience shall be the minimum, and the mere fact that a candidate possesses the same shall not entitle him/her for selection or interview. National Forensic Sciences University shall have the right General Instructions to restrict the number of candidates to be interviewed, if required to a reasonable level based on better or higher qualifications and experience than the minimum prescribed.
- 2. The contractual appointment shall end on the stipulated date of expiry of contract in appointment letter. Selected candidates shall have no right to renewal, extension of conversion into permanent employment.
- 3. The University retains the discretion not to make any appointment to this vacancy, to make an appointment at a revised remuneration, or to make an appointment with a modified job description and to fix revised qualification, experience, remuneration and requirements.
- 4. The applicant will be responsible for the authenticity of the information documents and photograph submitted.
- 5. The institute reserves the right to accept at applications any time, and consider candidates of exceptional credentials without applications.
- 6. Mere possessing the prescribed qualification does not ensure that the candidate would be selected. The candidates will be selected based on merit and the need of the project.
- 7. Candidates have to present themselves for the interview on the interview date with an updated CV, and original mark sheets/certificates in support of academic qualifications.
