2. **Minimum Eligibility Qualifications:** - Minimum eligibility qualification is as follows:-

(a) **Junior Scientific Officer (Forensic Science).**

Minimum Educational Qualification: - Masters degree in Forensic Science or related subjects such as Physics, Biology, Chemistry, Botany, Zoology, etc. from a recognized university.

Experience:-

- i. It is desirable that the candidate possess a minimum experience of three years in research and laboratory work in the areas of Forensic Science in any recognised institute or university or laboratory.
- ii. It is desirable that the candidate possess expertise in handling and working with various types of equipment and software related to Forensic Science.

(b) **Junior Scientific Officer (Cyber Security & Digital Forensics).**

Minimum Educational Qualification :- Master's Degree in Cyber Security / Digital Forensics / Information Technology / Computer Science / Electronics and Communication or equivalent with good academic record from a recognized University good academic record.

Experience:-

- i. It is desirable that the candidate possess a minimum experience of three years in research and laboratory work in the areas of Cyber Security & Digital Forensics in any recognised institute or university or laboratory.
- ii. It is desirable that the candidate possess expertise in handling and working with various types of equipment and software related to Cyber Security and Digital Forensics.

(c) **Assistant Controller of Examination.**

Minimum Educational Qualification: - Master's Degree with at least 55% of the marks or an equivalent grade in a point scale wherever grading system is followed.
