3. Place of Work and Facilities :-

- (a) <u>Place of Work</u> Selected candidates will be required to serve for three years at NFSU (India) campus at Jinja, Uganda. The appointment contract of employees posted at NFSU(I) Campus in Uganda may be curtailed or extended by NFSU as per the need of the Campus.
- (b) <u>Facilities</u> Candidates appointed and proceeding to NFSU (India) campus at Jinja, Uganda will be provided free air travel (to resume duty), free accommodation, free local transport for official purposes and free medical facilities in addition to the remuneration.
- **Remuneration** Appointed candidates **(on contract)** at NFSU (India) campus at Jinja, Uganda will be eligible to draw minimum Basic Pay for their post as consolidated amount. In addition, they will be paid the foreign allowance as per the post which is likely to be around US\$ 4,000/- per month subject to the Government of India/NFSU rules and norms.
- **Selection Process** Candidates desirous of applying for the above mentioned post(s) are to appear for 'Walk-In Interview' with documents and certificates supporting their qualifications. GENERAL INSTRUCTIONS, **ESSENTIAL INFORMATION** AND **CLARIFICATIONS**

- The Last Date for receipt of Online Applications is 25.07.2023.
- The experience and qualifications will be reckoned as the last date of ii) submission of the Online Application.
- The time taken by the candidates to acquire M.Phil and/or Ph.D degree iii) shall not be considered as teaching/research experience to stake a claim for appointment to the teaching positions.
- Excellent academic background, high-quality publications, potential to get iv) research funding from Government agencies and industries, appropriate academic professional activities undertaken, and a good innovative teaching record would be some of the important criteria for selection.
- Candidates shall enclose self-attested copies of certificates towards the v) evidence of Age, Educational Qualifications, Caste, Physical Disability, Experience, etc. with the applications.
- vi) The University reserves the right to fill or not to fill any or all the posts, without assigning any reason and no notice will be issued in this regard.
- The University shall verify the antecedents and documents submitted by vii) candidates during the time of interview and at any time, at the time of appointment, or during the tenure of service. In case it is detected that the documents submitted by the candidates are fake or the candidates have undesirable clandestine antecedents/background and have suppressed the said information, his / her services shall be liable to be terminated without citing any reasons for the same.
