- 3. The Admission Counselling process shall be as follows:
 - 3.1 You need to join the admission counselling ONLINE via the above link well within the time. You are required to keep your NFSU Application Number, One Valid Photo ID card (AADHAR Card/Passport/Driving License/Election Voter ID) in Original.
 - 3.2 The Admission Counsellor would call your ATTENDANCE and mark your presence in the counselling session. It is your sole responsibility to respond to your presence call failing which you shall be considered ABSENT and shall not be considered for the further process of admission.
 - 3.3 Once you confirm your willingness to take admission, the Admission Counsellor will send you an email (at Registered email ID) to make the payment.
 - 3.4 If you fail to attend the Counselling session or choose not to opt for admission process, you shall be deemed to have relinquished your claim for admission to NFSU for that respective program and campus, and your seat shall be given to the next person in merit.
 - 3.5 After receiving the "Provisional Admission Offer Email" which contains the payment link, you need to make payment of First Semester fees of INR 71,500. Please make sure of the following points (a to e) to avoid problems during online transactions.

- 3.6 Once you pay the fees, you will receive the payment receipt via email at your registered email ID.

4. Tie Breaking Rules:

In the case of the equal Marks in NFAT-2025 (i.e. same merit number), the following tiebreaking rules will be applied:

- a. For UG Programs:
 - i. The merit will be determined based on the percentage of Class XII.
 - ii. If the percentages in Class XII are also the same, the percentage of Class X will be considered.
- b. For PG Programs
 - Priority will be given to candidates whose results for the qualifying degree are available. The merit will be determined based on the percentage. If the result is in CGPA/CPI, it will be converted into a percentage using the respective university's formula.
 - ii. The candidates whose result of the final semester/year has not been declared will then be considered for the merit. The merit of these candidates will be based on the cumulative percentage of all semesters/years except the last semester/year.
