

2. Venue: Online Mode (Counselling time slots will be shared separately via email)

3. Merit-cum-Choice based Admission Process

The admission process at NFSU follows a merit-cum-choice system, where your rank in the merit list will be taken into consideration first along with your preferred academic program choices. During the counselling session, you will have an opportunity to discuss and finalize your program preferences based on your merit number and the availability of a seat in that category/campus.

4. Presence in Counseling: The candidate is required to be available for the online counseling session on the specified date. Candidates will receive the online counselling link & slots via email.

The counselling session is scheduled to begin promptly at 11:00 AM. However, it is essential that all the candidates need to be join online counselling before 15 minutes. Failure to join the counselling session will result in your absence being recorded because the seat allotment is based on merit and based on your presence at the time of your turn. Thus, your absence at the time of your turn will lead to the revocation of the admission offer for the respective program, and no further requests or communication regarding your admission will be entertained. It is crucial to adhere to the given time to ensure your eligibility and participation in the counselling process.

(proxy) to attend the counseling session on their behalf by providing duly signed written consent, the candidate must notify NFSU via email at admission_sms@nfsu.ac.in with valid supporting evidence at least 2-3 days prior to the aforementioned schedule so that special permission may be given. However, such permissions will be given rarely based on valid conditions.

If any candidate fails to attend the counseling session (with prior permission only), they will relinquish their right to admission to the respective program. No further requests or communications regarding this matter will be entertained.

5. Admission Fee Payment:

In order to secure your admission, you are required to pay the admission fees of <u>INR</u> 84000/-. NFSU offers the following multiple payment options for your convenience:

i. Online Payment: You can pay the admission fees online using UPI, Credit Card, Debit Card, or Internet Banking. Detailed instructions for online payment will be provided to you during the counseling session.

You are requested to make sure:

- · Your credit/debit card is enabled for online transactions.
- The daily transaction limit of the credit card is set appropriately.
- UPI transactions are enabled for the linked bank accounts.
- NEFT (National Electronic Funds Transfer): If you choose to pay via NEFT, the account details will be provided to you during the counseling session.
- a. Education Loan: If you are willing to get an educational loan from any bank/organization, you will have to pay the full fees to secure your admission on the day of counseling. Once your bank loan is approved and the total fees are paid by the bank to NFSU, you will get the total refund of your fees paid by you initially.
- b. SC/ST Category: The candidates who belong to SC/ST category will need to pay the fees to secure admission. Once the scholarship is received from the Government, you will get the total refund of your fees paid by you initially.

Note: Cash or Cheques will not be accepted as a mode of payment.



7. Required Documents:

Please keep the following documents ready in original and scan copy for verification during the counselling session:

- i. Valid ID Proof (any one of these: Aadhar card/Driving License/Voter ID/Passport)
- ii. Birth Certificate
- iii. 10th and 12th Standard mark sheet
- iv. Graduation all mark sheet
- v. Category Certificate (in case of reserved category as applicable)
- vi. Degree Certificate (if applicable)
- vii. Self-Declaration for Gap in the study (if applicable)
- viii. CAT Score card

8. OBC-NCL Certificate:

OBC candidates may note that the limit of annual income is Rs. 8 lakhs for determining the creamy layer among Other Backward Classes (OBCs) candidates. The OBC-NCL certificate issued for the **financial year 2023-24** by the Competent Authority in the prescribed format must be submitted at the time of admission failing which you will be considered in the OPEN category only.

9. EWS Certificate:

Economically Weaker Sections (EWS) candidates may note that the limit of annual income is Rs. 8 lakhs for determining the eligibility for benefits under Economically Weaker Sections (EWS) reservation. The EWS certificate issued for the **financial year 2023-2024** by the Competent Authority in the prescribed format must be submitted at the time of admission failing which you will be considered in the OPEN category only.

10. The candidates belonging to the other reservation categories (PwD, CW, and Kashmiri Migrants/Kashmiri Non-Migrants) need to bring the valid certificates in original for verification during the counseling session.

We encourage you to come prepared with any questions or concerns you may have regarding the academic programs or the admission process. 
