The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. - 6. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 60% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Special terms and conditions-Version:1 effective from 03-05-2024 for category Interactive Panel Solution for Institutions

- 1. Category cover supply and installation of the interactive panel with UPS required for institutions. Video conferencing camera included is an optional device and sellers may upload catalogue choosing relevant option accordingly.
 - 2. For the purpose of OEM status in the category only interactive panel shall be considered.

- 3. Scope of supply cover networking, cabling and electrical work involved in installation of system
- 4. Sellers who are uploading catalogues are requested to ensure that make and model of the additional item like UPS and Video conferencing camera (If offered) are indicated in the catalogues as per the relevant parameter and shall ensure that supply shall be made with same make and model only.
- 5. Equipment supplied shall be new, current models manufactured with new components and no refurbished or recycled component shall be used. All products supplied as per the category should be currently in production and not obsolete model. Seller shall ensure that the supplied goods are brand new, genuine / authentic, not refurbished, confirm to the description and quality as specified and are free from defects in material, workmanship and service.
- 6. Seller shall provide user documentation, system administration manuals, training material, operation manuals and maintenance procedures. Seller to assure that the equipment is performing as per the Standards laid down in the Operational Manual.
- 7. The cabling and ducting for the cabling will be done by the bidder in such a way that it should give an aesthetic look.
- 8. All the equipment's should be labelled with the details as below:
 - Name of the seller with phone numbers.
 - Warranty validity period
 - Toll free number for the customer care as per OEM
 - Call log website address.
 - Label sticker should be on the back side of the equipment and on the cover, they should be visible clearly.
- 9. The new releases (minor / major), versions, bug fixes etc. for the hardware and system software will be supplied at no extra charge, with necessary documentation.
- 10. Seller shall be responsible to ensure adequate and timely availability of spare parts needed for repairing the supplied goods at the service support centres/resident engineers during the warranty period.
- 11. Packing and Documents Seller shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination in transit, the packing shall be sufficient to withstand, without limitation, rough handling and exposure to extreme temperatures, salt and precipitation, and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the destination of the Goods and the absence of heavy handling facilities at all points in transit. Seller shall be responsible for any defect in packing and any material found damaged / defective at the delivery points and those are to be replaced by seller at their own risk and cost.
- 12. Sellers shall ensure that undertaking/Authorization from the OEM of the product offered indicating that same are not end of life and that OEM shall undertake to support the equipment/devices/software for the duration of the warranty offered.

- 1. Bidding may be submitted only by the 'Original Equipment Manufacturer' or their 'Authorized Dealers/resellers'.
- 2. Non-compliance of the tender terms, non-submission of required documents, lack of Clarity of the specifications, contradiction between the bidder specification and Supporting documents etc. may lead to rejection of the bid.
- 3. It is required that all bidders comply with the technical specifications, including any a dditional specifications. Accordingly, the submission of the Technical Specification Compliance, as outlined in the attached Annexure, is mandatory. Failure to submit this documentation will result in the rejection of the bid from the technical evaluation process, and no representations concerning this matter will be entertained. The University reserves all rights in this regard.
- 4. Additional Specification Parameters, if any Additional Specification Parameters as stip ulated in the Bid Document must be complied by the Bidder/Seller and supply may be made accordingly otherwise material will be liable for rejection.
- 5. The bidders are required to submit documents duly signed by the authorized represe ntative of the Firm / Company shall invariably be submitted/uploaded by the bidder(s) along with the bid for evaluation of the offer: the documents are attached in the "buye r added bid specific ATC"
- 6. Please Ensure to specify the Make and model of the offered Item. Mere Reproduction of the asked specification without any supporting official / printed brochure of the offer ed product may lead to rejection of bid.
- 7. The successful bidder shall be responsible for the uninstallation, transfer, and installation of the equipment's to the new location (Permanent Campus) as and when informed by NFSU Dharwad within 4 years from the date of first installation free of cost.
- 8. The following Buyer Added Bid Specific Terms and Conditions will apply for this bid. T hese Specific Terms and Conditions will modify / substitute / supplement the other clau ses mentioned in bid document. Whenever there is any conflict between the provision of other clauses mentioned in the bid document and that in the Buyer Added Bid Specific Terms and Conditions, the provision contained in the Buyer Added Bid Specific Terms and Conditions shall prevail.
- 9. EMD Exemption will be provided as per Government of India norms and guidelines.
- 10. NFSU Dharwad reserves the right to Cancel/Modify the bidding process fully or partiall y at any time without occurring any liabilities to NFSU Dharwad in this regard.
- 11. The Campus Director, NFSU, Dharwad Campus may seek any clarification / explanatio n / Documentary evidence related to offer at any stage from tenderers if required. How ever, any clarification / explanation or documentary evidence leads to implication on q uoted Price shall be considered only for placing the order but not for price evaluation.
- 12. Certification/Standard/Benchmarks: The goods must be certified based on applicable Standards like ISO, ISI, QCI, BIS or other international standards etc. The certificate for the Same should be attached with bidding documents.
- 13. Payment will be made on successful delivery, installation, training (if any).
- 14. No advance payment will be made. Payment will be processed through RTGS or onlin e transfer after the purchase order or work order is fully executed and all required doc uments are submitted, preferably within 30 days after satisfactory delivery, inspection , installation, and acceptance. The necessary documents include a pre-receipted tax in voice, delivery challan, warranty certificate, installation report in triplicate, and a Performance Bank Guarantee, all subject to verification.
- 15. The supplier must demonstrate that it has a proven appropriate set-up and capability to provide after-sales service efficiently and effectively.

16. Inspection after Installation & Commissioning of the equipment at consigne e's/User site:

- a. The goods will be inspected by Buyer / Consignee or their Authorized Representati ve or by Nominated External Inspection Agency (independently or jointly with Buy er or Consignee as decided by the Buyer) at consignee's premises for their compli ance to the contract specifications.

17. Defective Equipment:

- a. If any of the equipment supplied by the Tenderer is found to be Substandard, refur bished, un-merchantable or not in accordance with the Description/specification or otherwise faulty, the purchaser/consignee will have the right to Reject the equipment or its part. The prices of such equipment shall be refunded by the Tenderer with 18% interest if such payments for such equipment have already been made. All damaged or unapproved goods shall be returned at supplier. Defective part in Equipment, if found before installation and/or during warranty period, shall be replaced Within 30 days on receipt of the intimation from this office at the cost and risk of supplier Including all other charges. In case supplier fails to replace above item as per above terms and conditions, Purchaser/Consignee may consider "Banning" the supplier.
- b. Rejected items must be removed by the Bidders within one week from the date of rejection at their own risk and cost and replaced immediately. In case these are no t removed, these will be auctioned at the risk and responsibility of the suppliers without any further notice.
- 18. **Risk Purchase Clause:** In the event of failure of supply of the item/equipment within the Stipulated delivery schedule, the purchaser has all the rights to purchase the Item/equipment from the other source on the total risk of the supplier under risk purchase C lause.
- 19. **Resolution of Disputes:** The dispute resolution mechanism to be applied pursuant s hall be as follows: In case of Dispute or difference arising between the Purchaser and a domestic supplier Relating to any matter arising out of or connected with this agreeme nt, such disputes or Difference shall be settled in accordance with the Indian Arbitratio n & Conciliation Act, 1996, The rules there under and any statutory modifications or re-enactments thereof shall apply to the arbitration proceedings.
