Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. **1. Generic**

Malicious Code Certificate:

The seller should upload following certificate in the bid:-

(a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :-

- (i) Inhibit the desires and designed function of the equipment.
- (ii) Cause physical damage to the user or equipment during the exploitation.
- (iii) Tap information resident or transient in the equipment/network.

(b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.

**2. Generic**

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 50

percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 50 percent. Bidders are bound to accept the revised quantity or duration.

### 3. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

### 4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 5. **Past Project Experience**

**Proof for Past Experience and Project Experience clause:** For fulfilling the experience criteria any one of the following documents may be considered as valid proof for meeting the experience criteria:a. - **Contract Period:** One year from the date of contract order can be terminated anytime if service is unsatisfactory without compensation.
- **Coverage:** All consumables, spares, and labour for efficient operation except paper and electricity.
- **Quality of Parts:** Replacement parts must be new, genuine, and of the same brand quality.
- **Preventive Maintenance:** At least four preventive maintenance visits annually for functional checks, adjustments and minor tuning.
- **Response Time:** Complaints must be attended and faults rectified within 4 hours. For major repairs requiring workshop visits, machines must be returned within 48 hours.
- **Penalty:** Rs. 100 per day penalty for delays beyond 48 hours during major repairs, deducted from bills.

- Right to Service Elsewhere: The department may engage other service providers if needed.
- Fixed Rates: Approved rates remain unchanged during contract term.
- Contract Cancellation: The department reserves the right to cancel the contract anytime without assigning reasons; no compensation payable.
