For sale of bricks lied at permanent campus of NFSU- Tripura at Srinagar.

Sealed quotations are invited for the sale of bricks on "as is/ where is" basis through auction as per the terms and conditions given below:

1. The interested bidders may visit the site at below given address for inspection of bricks.

2. The approximate number of bricks is 60,000 nos. However, the bidder must visit the site and quote for total amount irrespective of number of bricks available there. The university intends to sale the bricks on as is where is basis, and will not entertain any representation for presence of lower number of bricks.
3. The interested firms/ person may quote their rates and other required details in the proforma given at Annexure on the same date in sealed envelope along with earnest money and copy of GST Registration certificate/ PAN. The rates may be quoted upto a maximum two digits after decimal. In case of more than two digits, the rate will be considered only upto two digits for financial evaluation (without any rounding).
4. Over-writing must be avoided; otherwise quotation is liable to be rejected.
5. The bidders must have GST registration/ PAN (either in the name of firm or sole proprietor) to participate in the tender and must submit self-attested copies of the same.
6. Sealed tenders along-with a demand draft for Rs.15,000/-as interest free earnest money in favour of The Campus Director, NFSU- Tripura Campus may be dropped in the tender box available in the office latest by 03.01.2023.
7. Reserve Price for this tender is Rs. 3.5 Lakhs payable by the Vendor to the university. Sealed tender should be properly superscribed as "Tender for auction of bricks etc." with complete address of the firm/ person on the sealed envelope.
8. Earnest Money will be refunded to the unsuccessful tenderers. However, the earnest money deposited by the successful tenderer will be kept as Security deposit. The same will be refunded without any interest after successful completion of the contract.
9. In case, the contractor fails to comply with the terms and conditions, the university may terminate the contract after forfeiting the security deposit without assigning any reasons and in such case, NFSU will be free to dispose-off bricks in such a manner as may be deemed appropriate.
10. Before lifting the bricks from site for permanent campus, the quoted money must be deposited in the university's account which will be mentioned in the contract order.

11. The cost towards taking out the lied bricks, their transportation, loading, unloading etc. will also be borne by the vendor himself with his labourers.
12. The Contractor must complete collection of the bricks on or before 06.01.2023. After this the university is not responsible for safe custody of bricks.
13. In case of unsatisfactory service rendered by the contractor, the university reserves the right to terminate the contract even during the period of the contract.
14. Non-compliance to the terms and conditions will result in the forfeiture of the Security Deposit. Similarly, non-acceptance of the contract by the successful tenderer will also result in the forfeiture of the Earnest Money.
15. The contractor will abide by the terms & conditions strictly.
16. Tenders will be opened at 17.30 pm on 03.01.2023 in presence of authorized representatives of the firms, who wished to be present, in the auditorium, NFSU- Tripura Campus, Radhanagar, Agartala, by the committee constituted for the purpose.
17. The tender will be awarded to the highest bidder.
18. In case of tie, the bidder with oldest date of GST Registration will be awarded the contract. In case of absence of GST registered party, the bidder who comes first as per alphabetical order of the name mentioned in PAN will be awarded the contract
