1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. 1. Bidding may be submitted only by the 'Original Equipment Manufacturer' or their 'Authorized Dealers/resellers'.
2. Non-compliance of the tender terms, non-submission of required documents, lack of Clarity of the specifications, contradiction between the bidder specification and Supporting documents etc. may lead to rejection of the bid.
3. It is required that all bidders comply with the technical specifications, including any additional specifications. Accordingly, the submission of the Technical Specification Compliance, as outlined in the attached Annexure, is mandatory. Failure to submit this documentation will result in the rejection of the bid from the technical evaluation process, and no representations concerning this matter will be entertained. The University reserves all rights in this regard.
4. Additional Specification Parameters, if any Additional Specification Parameters as stipulated in the Bid Document must be complied by the Bidder/Seller and supply may be made accordingly otherwise material will be liable for rejection.
5. The bidders are required to submit documents duly signed by the authorized representative of the Firm / Company shall invariably be submitted/uploaded by the bidder(s) along with the bid for evaluation of the offer: the documents are attached in the "buyer added bid specific ATC"
6. Please Ensure to specify the Make and model of the offered Item. Mere Reproduction of the asked specification without any supporting official / printed brochure of the offered product may lead to rejection of bid.
7. The successful bidder shall be responsible for the uninstallation, transfer, and installation of the equipment's to the new location (Permanent Campus) as and when informed by NFSU Dharwad Campus within 3 years from the date of first installation free of cost.
8. The following Buyer Added Bid Specific Terms and Conditions will apply for this bid. These Specific Terms and Conditions will modify / substitute / supplement the other clauses mentioned in bid document. Whenever there is any conflict between the provision of other clauses mentioned in the bid document and that in the Buyer Added Bid Specific Terms and Conditions, the provision contained in the Buyer Added Bid Specific Terms and Conditions shall prevail.

9. EMD Exemption will be provided as per Government of India norms and guidelines.
10. NFSU Dharwad Campus reserves the right to Cancel/Modify the bidding process fully or partially at any time without occurring any liabilities to NFSU Dharwad Campus in this regard.
11. The Campus Director, NFSU, Dharwad Campus may seek any clarification / explanation / Documentary evidence related to offer at any stage from tenderers if required. However, any clarification / explanation or documentary evidence leads to implication on quoted Price shall be considered only for placing the order but not for price evaluation.
12. Certification/Standard/Benchmarks: The goods must be certified based on applicable Standards like ISO, ISI, QCI, BIS or other international standards etc. The certificate for the Same should be attached with bidding documents.
13. Payment will be made on successful delivery, installation, training (if any).
14. No advance payment will be made. Payment will be processed through RTGS or online transfer after the purchase order or work order is fully executed and all required documents are submitted, preferably within 30 days after satisfactory delivery, inspection, installation, and acceptance. The necessary documents include a pre-receipted tax invoice, delivery challan, warranty certificate, installation report in triplicate, and a Performance Bank Guarantee, all subject to verification.
15. The supplier must demonstrate that it has a proven appropriate set-up and capability to provide after-sales service efficiently and effectively.
16. **Inspection after Installation & Commissioning of the equipment at consignee's/User site:**
 - a. The goods will be inspected by Buyer / Consignee or their Authorized Representative or by Nominated External Inspection Agency (independently or jointly with Buyer or Consignee as decided by the Buyer) at consignee's premises for their compliance to the contract specifications.

17. Defective Equipment:

18. The rejected items shall be removed by the bidders within ten (10) days from the date of rejection, entirely at their own risk and cost, and shall be replaced forthwith. In the event of non-removal within the stipulated period, the said items shall be disposed of or utilized at the sole risk and responsibility of the suppliers, without any further notice, and no subsequent claim or payment shall be entertained.
19. **Risk Purchase Clause:** In the event of failure of supply of the item/equipment within the Stipulated delivery schedule, the purchaser has all the rights to purchase the Item/equipment from the other source on the total risk of the supplier under risk purchase Clause.

Special Terms and Conditions (STC) for DVR Examiner (3 Year License)

1. Scope of Supply and SITC :

- a. The scope of work includes Supply, Installation, Testing, Commissioning (SITC) and successful demonstration of the DVR Examiner software, including all licensed modules, features, and utilities as specified in the technical specification.
- b. Demonstration shall cover forensic acquisition, analysis, reporting, and academic use cases, as required by the End User.
- c. In case the software is initially deployed at a temporary campus or interim location, the bidder shall: Reinstall, Reconfigure, Re-commission of the complete forensic academic programme at the permanent campus, at no additional cost, even if the original warranty/support period has expired.

2. Platform Compatibility:

- a. The software must support Windows, macOS, and Linux platforms.
- b. Platform & Environment Compliance: The DVR Examiner software must support Windows, macOS, and Linux platforms. The software shall function in offline / air-gapped environments without mandatory internet connectivity and any cloud-based features shall be optional and user-controlled.

3. Bidder Qualifications:

The bidder shall submit performance certificates from at least three (03) clients for similar forensic academic software supplied within the last three (03) years. Each certificate must include verifiable email ID and mobile number of the client authority. Installation reports alone shall not be accepted as performance certificates. If adverse feedback or poor performance is confirmed during verification, the bid shall be liable for rejection.

4. Completeness and Documentation :

- a) The vendor shall supply all required software modules, licenses, and ac

cessories necessary for full operation of the DVR Examiner software. No essential feature shall be quoted as optional if required to meet the technical specification.

- b) Bidder shall submit: Product brochure, technical catalogue, operational manual and specification compliance documents.

5. Indemnity:

Bidder indemnifies buyer against licensing disputes; replaces invalid licenses at own cost.

6. License Type and Scope:

- a) The software shall be supplied as an Educational / Academic License in the name of National Forensic Sciences University, Dharwad Campus, for academic and training use only.
- b) License shall permit installation and use strictly for teaching, laboratory exercises, research and internal academic projects.
- c) The license shall be for three (03) years from the date of commissioning, with rights to use all minor updates released during the license period.
- d) Offline activation supported; no usage caps on cases/images beyond OEM limits. Genuine OEM certificates required at SITC.
- e) Network license shall support concurrent use from the university LAN (wired / wireless).

7. Usage Restrictions and Compliance:

- a) Software shall not include any usage cap (cases, images, items, size) other than OEM's standard technical limits; no artificial restriction based on time, investigation count or number of cases is permissible for the academic license.
- b) The bidder / OEM shall ensure that the supplied license permits use of all features requested in the technical specifications.
- c) Bidder shall indemnify the buyer against any claim arising out of use of pirated, improperly licensed or non-compliant software; in such case bidder shall replace the license at own cost and bear any legal / financial consequences.

8. Warranty, Support and Updates (Software):

- a) The bidder/OEM shall provide minimum three (03) years onsite comprehensive OEM warranty and technical support, effective from the date of final acceptance. The warranty shall include software updates, patch fixes, technical assistance, documentation support; OEM warranty certificates must be submitted at the time of commissioning.
- b) During warranty / support period, bidder / OEM shall provide:
 - Free updates / patches / minor upgrades of the licensed version;

9. Technical Compliance Requirement:

10. Data Privacy and Security:

- a) No case data, images, hash sets or student information shall be transmitted outside the NFSU network without written permission of the buyer; all cloud-based features, if any, shall be disabled unless explicitly approved.
- b) Support access to NFSU systems (remote desktop / VPN) shall be provided only with prior written approval for specific incidents and shall be logged by the university.

11. OEM Authorization and Experience:

Bidders/OEM must provide valid authorization certificate from OEM, proof of 3 years supplying similar forensic DVR analysis software to Central/State Govt/PSUs, and OEM average turnover of at least ₹200 Lakh over last 3 years. Past performance requires 80% bid quantity supplied in one of the last 3 FYs.

12. Installation, Training, and Support:

OEM/OEM-certified personnel shall handle installation, commissioning, testing, configuration, and training for 3-6 users within 30 days of delivery. 3-year comprehensive warranty with 4-hour onsite response; annual maintenance post-warranty optional.

13. Data Security and Compliance:

Software must be IPv6-ready, free of malicious code (with certification), and compliant with IT Act 2000, GDPR-equivalent standards, and NFSU data policies. No hard disk return for faulty units; all data encrypted (AES-256).

14. Testing and Validation:
