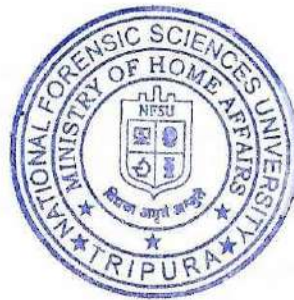

1. Sealed NIQ on percentage rate basis are invited by NFSU, Tripura Campus from having valid GST and PAN. The approximate cost of the work is Rs. 1,45,057/- (Rupees One Lakh Forty Five Thousand Fifty Seven only). The work to be completed within **30 days** from the date of acceptance of work order placed by NFSU, Tripura Campus or as from the date mentioned in the work order.
2. The participants are required to quote rate as per the site visit done on percentage rate basis. **The NIQ will not be accepted in other format.** The completed set is to be put in a sealed envelope addressed to:

**NIQ will be submitted at "Tender Box inside Admin Building, Ground floor, up to 03:00 PM on 16.06.2023" with necessary documents.**

Earnest Money Deposit (EMD) of **Rs. 2,901/-** (Rupees Two Thousand Nine Hundred One only) to be submitted in the form of demand drawn in favour of Campus Director, NFSU, Tripura Campus along with techno financial documents.

**Scope of Work: -:** Providing and fixing of false ceiling in the multipurpose hall of NFSU, Tripura Campus.

**Agency has to submit the copies of the documents. Without these documents NIQ will not be accepted.**

- A. Copy of PAN card.
- B. Copy of GST.
- C. EMD receipt/certificate for its exemption.

3. No NIQ will be received after the expiry of the date/ time notified for receiving NIQs under any circumstances whatsoever.
4. The NIQ will be opened at **04:00 PM on 16.06.2023** at above address, in the presence of authorized representative of Contractor or contracting agency if present at office at given date and time and NIQ opening committee of NFSU, Tripura Campus.
5. NIQ shall remain valid for acceptance for a period of 90 days from the notified last date of NIQ submission.
6. NFSU, Tripura Campus reserves the right to reject any or all NIQ received without assigning any reasons thereof.
7. The price should be for the complete finished item of work and include all labour, material, taxes, overhead, duties, cess etc.
8. All NIQs in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.
9. NFSU, Tripura Campus reserves the right to reject any or all prospective applicants without assigning any reason. If any information furnished by the applicant is found incorrect at a later stage, he/she shall be debarred from participating and taking up of any work in NFSU, Tripura Campus.
10. This NIQ notice shall form part of the contract documents.
11. Penalty @ 0.5% per week subject to maximum 10% will be imposed against delayed part of work.
12. The agency is fully responsible for the safety of working personnel and has to follow all government labour law

and safety rules.

13. Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the work, the form and nature of site, the means to access the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risk, contingencies and other circumstances which may influence or affect their NIQ. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost of materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the bid documents. Submission of NIQ by a NIQer implies that he/she has read this notice and all other NIQ documents and has made himself/herself aware of the scope and specifications of the work to be done and local conditions and other factors having bearing on the execution of the work.
14. All statutory deduction will be deducted as per government rules.
15. Payment shall be released through Bank Account after submission of Bill against work done.
16. All disputes are subject to exclusive jurisdiction of competent court and forum in Agartala, India only.
17. The work shall be carried out as per C. P. W. D specifications for works with correction slips issued up-to date unless otherwise specified in the schedule of quantities for the works.
18. Water, electricity will be made available on chargeable basis (1%) will be deducted out of total bill amount, if provided by NFSU, Tripura Campus.
19. Being and individual works contract/maintenance contract, sales tax, excise duty etc are not payable separately. The works contract tax, income tax and Labour cess shall be deducted from the bills of the contractor at the prescribed rate wherever applicable. The contractor shall be responsible to pay any applicable safety liabilities to the respective authority as per applicability within quoted rates.
20. The work will be carried out as per instructions given by the Officer- in - Charge and as per the required work and the contractor shall be bound to carry out the work in accordance with revised and / or modified drawing.
21. All the materials to be used in the work shall have to be got approved by the Officer-in-charge prior to fixation.
22. No under-ground work or above the false ceiling shall be covered until the same has got approved by the Officer-in-charge. The contractor will supply the drawings of specific works for approval, if required.
23. The contractor shall arrange suitable godown at the site of work for storing their materials safe against damage at his/her own cost and he/she shall employ necessary watch and ward establishment for tool and plants and other materials at his/her own cost.
24. The contractor is assumed to have visited the site before quoting the rates and so the work is to be completed in all respects before handover.
25. All debris/ malwa should be removed by respective agency within 2 days of completion of work.
26. If any extra work is to be executed or any item of B.O.Q is substituted during the course of the work due to some modifications in the requirement of user or due to any cause required essentially for proper functioning of the work, the same shall be paid to the successful agency on DSR'2021 rates quoted by the agency.

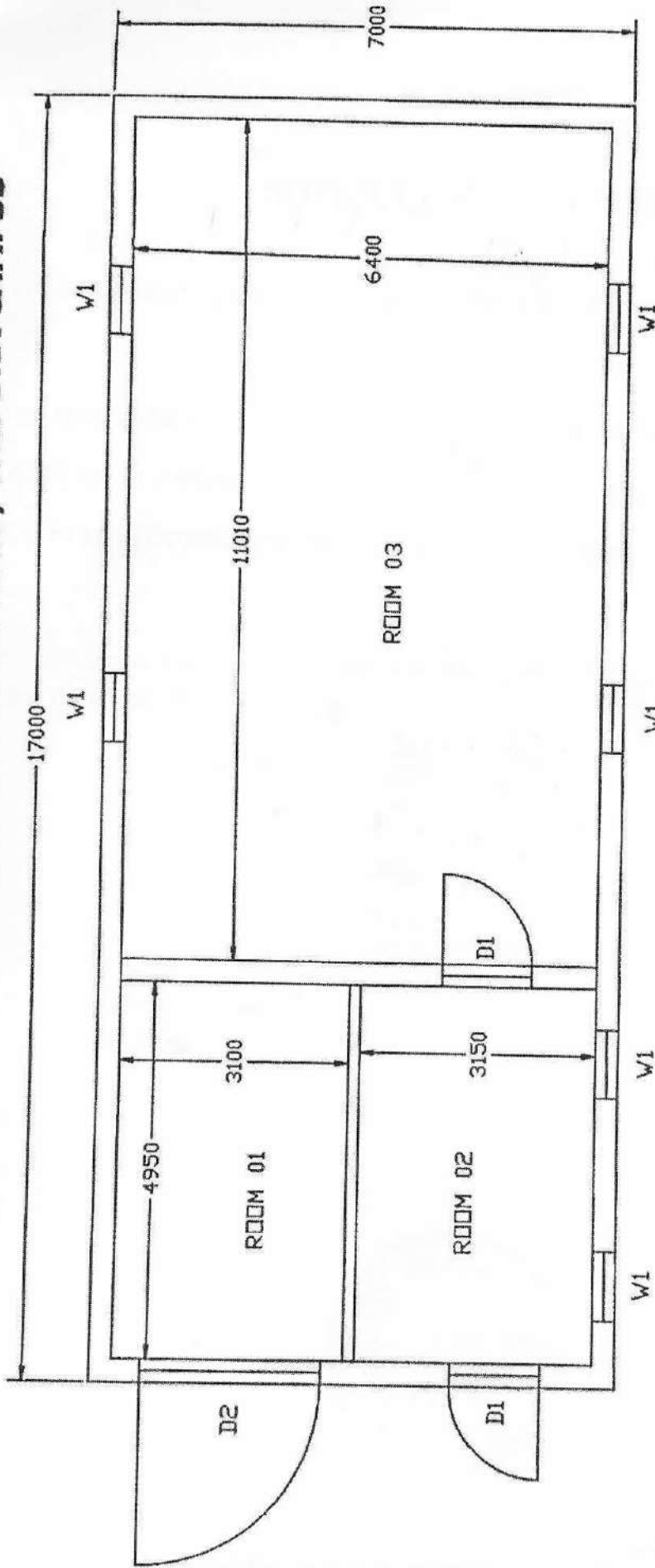
