Sealed quotations are invited for the Demolishing of dilapated Permanent structure including costing of dismantle Material and clearing the site for new Construction as demarcated at NFSU-Tripura Campus on "as is/where is" as per the terms and conditions given below:

2. The approximate area for the new construction is 40 meters x 18 meters, in which dilapated Permanent structure exists, which will be dismantled. However, the bidder must visit the site.
3. The interested firms/person may quote their rates and other required details in the proforma given at Annexure in sealed envelope. The rates may be quoted up to a maximum two digits after decimal. In case of more than two digits, the rate will be considered only up to two digits for financial evaluation (without any rounding).
4. The interested firms/person will have to deposit **Earned Money amounting to Rs 75,000/- (Rupees Seventy Five Thousand only)** in the Bank Account of NFSU and submit the proof of deposit along with the bid document. **The earnest money will be adjusted against the Quoted Price for the H-1 bidder and for rest of the bidders the amount will be refunded within 7 days.** The Bank Account details are as under :-

5. Over-writing must be avoided; otherwise, quotation is liable to be rejected.
6. Sealed tender may be dropped in the tender box available in the office latest by 1500 hrs on or before 25 March 2025.
7. Reserve Price for this tender is Rs 2,75,986/- (excluding GST, as applicable). Sealed tender should be properly superscribed as "Re-Tender for Demolishing of dilapated Permanent structure including costing of dismantle Material and clearing the site for new Construction as demarcated at NFSU-Tripura Campus at Radhanagar" with complete address of the firm/person on the sealed envelope.

8. The Earnest Money Deposit will be adjusted against the quoted price of the H-1 bidder and the balance quoted amount will be paid in two instalments before the completion of the work.
9. In case, the contractor fails to comply with the terms and conditions, the university may terminate the contract without assigning any reasons and in such case, NFSU will be free to dispose-off in such a manner as may be deemed appropriate.
10. The cost towards transportation, loading, unloading etc. will also be borne by the vendor himself with their labourers. The vehicle with trailer larger than 4.7 meter will not be allowed to enter into the Campus.
11. The contractor must complete the work within 45 days (Forty Five) from the date of award of contract. The university is not responsible for safe custody of dismantle Material.
12. In case of unsatisfactory service rendered by the contractor, the university reserves the right to terminate the contract even during the period of the contract.
13. The contractor will abide by the terms & conditions strictly.
14. Tenders will be opened at 1530 hrs on 25th March 2025 in presence of authorized representatives of the firms, who wished to be present in the NFSU-Tripura Campus, Radhanagar, Agartala by the committee constituted for the purpose.
15. The tender will be awarded to the bidder quoting the highest rate.
16. The tenderer will be authorised CPWD/Tripura PWD enlisted contractor.
17. In case, of any dispute, the decision of the Campus Director, NFSU will be final and binding to all.
