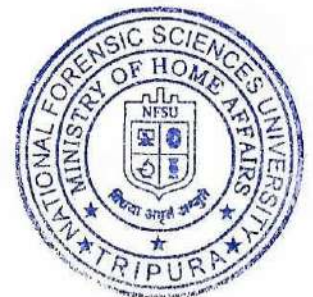


AUCTION NOTICE

For sale of bricks stacked at transit campus of NFSU- Tripura at Radhanagar.

Sealed quotations are invited for the sale of bricks on "as is/ where is" basis through auction as per the terms and conditions given below:

1. The interested bidders may visit the site at below given address for inspection of bricks.
Bricks are stacked at the address indicated below:

2. The approximate number of bricks is 50,000 nos. However, the bidder must visit the site and quote for rate per thousand and number of bricks interested to buy.
3. The interested firms/ person may quote their rates and other required details in the proforma given at Annexure in sealed envelope. The rates may be quoted up to a maximum two digits after decimal. In case of more than two digits, the rate will be considered only up to two digits for financial evaluation (without any rounding).
4. Over-writing must be avoided; otherwise, quotation is liable to be rejected.
5. Sealed tenders may be dropped in the tender box available in the office latest by 25.05.2023.
6. Reserve Price for this tender is Rs. 5,500 per thousand (standard size bricks) & 3,500 per thousand (Bat bricks) payable by the Vendor to the university. Sealed tender should be properly superscribed as "Tender for auction of bricks etc." with complete address of the firm/ person on the sealed envelope.
7. In case, the contractor fails to comply with the terms and conditions, the university may terminate the contract after forfeiting the security deposit without assigning any reasons and in such case, NFSU will be free to dispose-off bricks in such a manner as may be deemed appropriate.
8. Before lifting the bricks from transit campus, the quoted money must be deposited in the university's account which will be mentioned in the contract order.
9. The cost towards transportation, loading, unloading etc. will also be borne by the vendor himself with their labourers. The vehicle with trailer larger than 4.7 meter will not be allowed to enter into the Campus.
10. The Contractor must complete collection of the bricks on or before 7 days of date of award of contract. After this the university is not responsible for safe custody of bricks.
11. In case of unsatisfactory service rendered by the contractor, the university reserves the right to terminate the contract even during the period of the contract.
12. The contractor will abide by the terms & conditions strictly.



13. Tenders will be opened at 17.00 pm on 25.05.2023 in presence of authorized representatives of the firms, who wished to be present, in the auditorium, NFSU- Tripura Campus, Radhanagar, Agartala, by the committee constituted for the purpose.
14. The tender will be awarded in the following way
 - (a) The bidder quoting the highest rate per thousand will be awarded the contract for buying the number of bricks mentioned in their quotation intended to buy.
 - (b) If some bricks are left after award of contract to the bidder as mentioned in (a) above, then the bidder quoting the second highest rate per thousand will be awarded the contract for buying the number of bricks mentioned in their quotation or number of bricks left after (a) above, whichever is lower.
 - (c) If some bricks are still left after award of contract to the bidder, then the bidder with third highest rate per thousand, will be awarded the contract in the same fashion, and so on till all bricks are sold.
