## 1. General Instruction to Bidders

- 1.1. Bids shall be submitted online only at CPPP website: <http://eprocure.gov.in/eprocure/app>.
- 1.2. The complete bidding process in online. Bidders should be possession of valid digital Signature Certificate (DSC) of class II or III for online submission of bids. Prior to bidding DSC need to be registered on the website mentioned above. For any assistance for e-bidding process, if required, bidder may contact to the helpdesk at 0291-2740741.
- 1.3. Tenderer/Contractor/Bidders are advised to follow the instructions provided in the 'Instructions to the Contractors/Tenderer/Bidders for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>
- 1.4. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 1.5. **EMD Payment:**

The bidder shall be required to submit an Earnest Money Deposit (EMD) of Rs. 1,00,000.00 through Demand Draft (DD), FDR or Bank Guarantee (BG) only. It shall be drawn in favour of "Campus Director, NFSU Gandhinagar Campus." The EMD of the successful bidder will be returned after the submission of the required Bank Guarantee / Security Deposit. The EMD of the unsuccessful bidder(s) will be returned after the award of the contract. The original DD, FDR or BG for the EMD must be delivered to NFSU, Gandhinagar on or before the last date and time of bid submission.

  - A. No request for transfer / adjusts of any previous deposit of earnest money or security deposit or payment of any pending bill held by the University in respect of any previous supplies will be entertained.
  - B. Tenderer shall not be permitted to withdraw his offer or modify the terms and conditions thereof. In case the tenderer fails to observe and comply with stipulation made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.
  - C. The Tenders without Earnest Money will be summarily rejected.
  - D. EMD Exemption: As per Rule 170 of GFR, the EMD exemption is applicable to Micro and Small Enterprises (MSEs) and Start-ups (recognized by DPIIT). In view of the above, if the bidder will claim for EMD exemption, the bidder should meet all the criteria for Micro and Small Enterprise. The bidder must have to submit the supporting documents like NSIC registration certificate, MSE registration certificate etc. issued by competent government bodies to become eligible for EMD exemptions. The certificate shall be valid as on due date/extended due date of the tender.
  - E. No Claim shall lie against the NFSU in respect of erosion in the value or interest on the amount of EMD.
  - F. The EMD, in case of successful bidders shall be returned after submission of performance security and in case of unsuccessful Bidders shall be retained by the Purchaser, up to a maximum period of 6 months from the date of opening of the Bids or till the finalization of the tender, whichever is later. The bid security shall be refunded to the unsuccessful tenderers on written request. No interest will be payable by the NFSU authorities on the EMD.

- 1.6. The Hard copy of original documents in respect of earnest money deposit and Technical Bid along with printed product catalogue must be delivered to the NFSU, Gandhinagar on or before last date/time (17.10.2025 till 18:00 PM) of bid without EMD will be summarily rejected.
- 1.7. Before formulating the bid and submitting the same to the purchaser, the bidder should read and examine all the terms, conditions, instructions, etc. contained in the Tender Document. Failure to provide and/or comply with the required information, instructions etc. incorporated in these Tender Documents may result in rejection of its Bid.
- 1.8. The rates quoted, approved and accepted by the Campus Director, NFSU Gandhinagar shall be valid for one (01) year from the date of award of contract. (Extendable on mutual agreement, if required).

**1.9. Submission of tender:**

The tender shall be submitted in two part, viz., **technical bid (submitted in Online and physical along with EMD & printed product catalogue) and Price bid (submitted in Online, BOQ (in PDF format).** All the pages of bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before uploading. The offers submitted by Email shall not be considered. No correspondence will be entertained in this matter.

## 2. General Terms and conditions

**Subject: Notice inviting bids for rate contract for supply of chemicals, Plasticware, Glassware, reagents, certified reference materials (CRM), refilling of various gases & other Laboratory Consumables at NFSU (National Forensic Sciences University), Gandhinagar Campus.**

National Forensic Sciences University (NFSU) is going to initiate Rate Contracts of Chemicals, Plastic wares, Glassware, Reagents, Certified Reference Materials (CRM), refilling of various Gases & other Laboratory Consumables. These all items are used on a regular base in all the Departments and the Laboratory.

### Categories of Consumables for Rate Contract:

- Category A: Chemicals
- Category B: Plasticware
- Category C: Glassware
- Category D: Reagents
- Category E: Certified Reference Materials (CRM)
- Category F: Refilling of Various Gases

#### 2.1. Parties:

The parties to the contract are the contractor (the tenderer to whom the work have been awarded) and the NFSU through authorities of NFSU, Gandhinagar campus for and on behalf of the campus director, NFSU Gandhinagar Campus.

#### 2.2. Due date:

The tender has to be submitted online (both technical and price bid) /Physical (only technical bid) before the due date. The offers after the due date and time will not be considered.

#### 2.3. Representation/Clarification:

Pre-Bid meeting will not be conduct but Bidders are advised to submit any kind of representation in soft copy via email on [Purchase\\_gnr@nfsu.ac.in](mailto:Purchase_gnr@nfsu.ac.in) on or before the 02.10.2025. Representations received thereafter will not be considered further, please noted.

2.4. Proposal for rate contract may be submitted in the prescribed format and all columns may be filled up. Incomplete proposals and tenders received after due date shall not be entertained. The University shall not be responsible for any postal delay and delay in receipt of the offer. Any bids received by the University which does not fulfill the desired terms and conditions shall be rejected out rightly and no communication in this regard shall be sent. Delayed / Late Bids will not be accepted, at any circumstances.

2.5. Quotations qualified by such vague and indefinite expression such as “Subject to prior confirmation”, “Subject to immediate acceptance” etc. will be treated as vague offers and rejected accordingly. Any conditional tender shall be rejected summarily.

2.6. The Manufacturers (OEMs) / principals offering for the Rate Contract may furnish the name and address of their local authorized distributor / dealer, so that the copies of orders can be endorsed to them for expeditious supply. In such cases where local dealers / stockiest has been nominated by the principal, the bills raised by them against our purchase order will be accepted.

2.7. Any addition and deletion of authorized dealership / distributorship shall be intimated to the undersigned immediately on authorization of a new party.

- 2.8.** At any time prior to date of submission of tender, Tender Inviting Authority may, for any reason or decision, modify the terms & conditions of the tender document by a corrigendum displayed on the website of NFSU (<http://www.nfsu.ac.in>). In order to provide reasonable time to take the amendment into account in preparing their bid, Tender Inviting Authority may or may not, at his discretion, extend the date and time for submission of tenders.
- 2.9.** After the opening of financial bid, the technical qualified bidders may be requested to submit a soft copy of Printed price catalogue in searchable format.
- 2.10. Discount:**  
The Discount which will be offered by the manufacturer/authorized distributors on the manufacturer's price list for the year 2025-26 may be mentioned in BoQ (In form of PDF). Firms must offer a flat discount on whole MAKE/ORIGIN instead of separate discount on different item wise in Category like Plasticware, chemicals, glassware etc.
- 2.11.** An undertaking may be given that the price list being furnished with the proposal will remain valid for the current rate contract irrespective of validity period.
- 2.12.** Where contract (RC) for supply of goods, etc. imported (Subject to custom duty and foreign exchange variations) and/or locally manufactured (Subject to excise duty and other duties & taxes), the percentage of discount should be specifically stated along with the selling rates of foreign exchange element considered in the calculation of the price list of the imported items. (specially Category of CRM)
- 2.13.** In case of supply of goods made through valid authorized dealer, their name & mail address may be declared / indicated in the tender.
- 2.14.** Authorization certificate in respect of foreign firms duly self-attested and showing validity period may be submitted.
- 2.15.** Enlistment under Rate Contract with this University does not ensure business of any quantum, whatsoever. Any deviation from the Terms & Conditions mentioned above will imply disqualification for the firm.
- 2.16. Preparation of Bids:**  
The offer/bid should be submitted in two bid systems i.e. Technical bid and Price bid.
- 2.16.1.** The Technical bid should consist of all technical details (Annexure -X) along with terms and conditions, detailed formatted attached at Annexure - I. The Technical bid (Submitted in online and physical mode also)
- 2.16.2.** Price bid should indicate Make wise discount for the Category (Make/origin) mentioned in the technical bid and given format in the i.e. BoQ\_PDF. and the price bid should be submitted only Online (in PDF Format), to be downloaded first and uploaded after filling all relevant information strictly as per the format failing which the offer is liable for rejection. Kindly clearly mentioned quote your offer discount on FDR NFSU, Gandhinagar (Inclusive all tax and charges). Vendor should quote discount in BOQ only, offers indicating rates anywhere else shall be liable for rejection. (Annexure -XI)

**Note:** Only the bids submitted for the specified Make discount will be considered for comparison. Any item or feature marked as 'Optional' in the specifications will not be included in the overall evaluation. The bid offering the highest discount will be final considered during evaluation.

## 2.17. DOCUMENTS COMPRISING THE BID:

The Two Bid System, i.e. “**Technical Bid**” and “**Price Bid**” prepared by the bidder shall comprise the following:

### Cover 1: Technical Bid

To qualify in the Technical Bid the firm should have the minimum eligibility criteria as under and the firm in this regard must submit (Online/Physically) the following documents in support of their eligibility criteria: -

- A. Technical Information/Checklist for bidder and Undertaking as per **Annexure – I** Contract Form
- B. Valid registration certificate of the firm of the Govt. / State Govt.
- C. Scanned copy of Earnest Money Deposit and Bank Details. (**Annexure -V**)
- D. Scanned copy of “List of Companies Quoted”/ Technical Compliance list as per (**Annexure – X**).
- E. Scanned copy of Manufacturer Authorization as attached, if quoted on behalf of Principle Manufacturer / Company / Importer. (**Annexure – VIII**).
- F. Scanned copy of Tender Acceptance Form to be uploaded. (**Annexure -VII**)
- G. Copy of constitution or legal status of the bidder manufacturer / Sole proprietorship / Partnership firm / Company / agency etc.
- H. Printed catalogue for 2025-26 (Both hard copy and soft copy) duly signed & certified by authorized signatory must accompany the tender.
- I. The bidder must upload scanned copy of a Non-Blacklisting Certificate that the firm has not been blacklisted in the past by any government / private Institution on non-judicial stamp paper of Rs. 100/-,
- J. Scanned copy of No Deviation Certificate on non-judicial stamp paper of Rs. 100/-
- K. Scanned copy of Price Justification Certificate on non-judicial stamp paper of Rs. 100/-
- L. Scanned copy of Land Border Declaration.
- M. Financial Status: - The average annual turnover for the last three financial years (i.e. F. Y.: 2022-23, 2023-24, and 2024-25) must be greater than 1 Cr, Copies of profit & loss account and balance sheets duly authenticate by a Chartered Accountant for the last three years should be enclosed.
- N. Scanned copy of Income Tax Return Acknowledgement for last Three years (i.e. F. Y.: 2022-23, 2023-24, and 2024-25).
- O. Scanned copy of PAN Card
- P. Scanned copy of GST registration certificate.
- Q. Undertaking for shelf life
- R. Details of clients where similar services are presently provided by the tenderer separately for govt. and private clients.
- S. The bidder must have adequate experience of execution of similar work in Govt. offices / PSUs / Autonomous Bodies and other similar organizations. Necessary supporting documents

like work orders, work completion certificate, payment certificate etc. for last three years to this effect must be submitted along with the offer.

- T. The concerned firm/company whose product has been declared as of spurious or adulterated quality and any criminal cases is filled and is pending in any court shall not be eligible to participate in the bidding process. Convicted firms/company shall also not be eligible to participate in the bid. Similarly, blacklisted / banned / debarred firms / company by any central / state govt. or its organization or autonomous bodies or central drug procurement agency is not eligible to participate in the bid.
- U. Brochure, original technical catalogue with detailed specification and picture of the product offered, if relevant
- V. Quality Assurance Certificate (Must be submitted in your company letter head)
- W. If the Local Authorized Dealer of any Manufacturing Company is participating in this Tender, additionally, he will be required to submit the following document from the Principal Manufacturer:
- I. Manufacturer's Authorization Certificate from Principal manufacturer.
  - II. Printed Product Catalogue for 2025-26 (Both hard and soft copy) duly signed & certified by authorized signatory.
  - III. Scanned copy of Non-Blacklisting Certificate on non-judicial stamp paper of Rs. 100/-
  - IV. Scanned copy of Land Border Declaration.
  - V. Scanned copy of turn over certificate for last three years (F.Y.: 2022-23, 2023-24, and 2024-25)

### **Cover 2: Price Bid**

Price Bid: A standard BOQ format has been provided in PDF format (Annexure XI). Bidders are required to download the BOQ pdf file and fill their financial offer on the same BOQ format. After filing the same, submit it online in pdf format, without changing the financial template format. Further please attached discount authorization certificate along with fall clause undertaking on your company letter head.

**Note: If the bid is incomplete and / or non-responsive it will be rejected during technical evaluation. The bidder may not be approached for clarifications during the technical evaluation. So, the bidders are requested to ensure that they provide all necessary details in the submitted bids.**

#### **2.18. Bid Opening:**

**2.18.1.** Technical Bid will be opened on 18.10.2025 @ 18:00 Hrs.

**2.18.2.** Price Bids of the eligible bidders will be opened on a later date. The date and time for opening of Price Bids will be announced later.

**2.18.3.** Bids should be summarily rejected, if tender is submitted other than through online or original EMD/bid security declaration are not submitted within stipulated date/time.

#### **2.19. Bid Currencies:**

The bidder supplying indigenous goods or already imported goods shall quote discount only on Indian Rupees (INR). Bids, where prices are quoted in any other way shall be treated as non – responsive and rejected.

**2.20. Validity of the bids:**

The bids shall be valid for a period of 180 days from the date of opening of the tender.

**2.21. Right of acceptance:**

The NFSU, Gandhinagar reserve the right to accept the whole or any part or portion of the bid; and the bidder shall provide the same at the Discount quoted. The NFSU, Gandhinagar reserve the right to reject any or all tenders / quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claim in this regard shall be entertained.

**2.22. Firm Price:**

Discount quoted on respective category by the bidder shall remain firm and fixed during the period of the Rate Contract and not subject to variation on any account. Purchase Orders will be placed by Schools/ Centers / Departments / Store Sections against this Rate Contract till the period of Rate Contract. Statutory variation in GST will be applicable.

**2.23. Alternative Models / Brands / Quality:**

Alternative Models / Brands / Quality are not permitted. The Bidder are required to quote Models/Brands/Quality of best quality meeting tender specifications. Wherever, a bidder quotes alternative Models / Brands / Quality, there bid will not be considered for that item.

**2.24. Purchase Preference to Local Suppliers:**

Refer revised Public Procurement (Preference to Make in India), Order 2017, No. P-45021/2/2017-PP (B.E II) dated 16.09.2020 issued by DPIIT, Ministry of Commerce and Industry, Govt. of India. (Submit duly filled 'Annexure-IX' for the same). The 'Annexure-IX' once submitted in the Technical Bid will be final. Submission of Revised 'Annexure-IX' will NOT be accepted.

**2.25. Minimum local content:**

The minimum local content shall as per Government of India Order No P-45021/2/2017-PP (B.E II) dated 16.09.2020 (as amended from time to time), till the Nodal Ministry prescribes a higher or lower percentage.

**2.26.** The bidders are required to submit the following annexure in compliance of public procumbent (Preference to Make in India) order, 2017:

**2.27.** Affidavit of self-certification regarding local content (to be provided on Rs. 100/- stamp paper). (Annexure- IX).

**2.28.** All other terms & conditions will be as per the Department of Industrial Policy and Promotion (DIPP) order No. P-45021/2/2017-PP (B.E II) dated 16.09.2020 (as amended from time to time).

**2.29. Signing of Tender:**

Individual signing the tender or other documents connected with contract must specify whether he sign as:

- A. A sole proprietor of the concern or constituted attorney of such sole proprietor;
- B. A partner of the firm, if it is a partnership firm in which case he must have authority to execute the contracts on behalf of the firm and to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership agreement or by a power of attorney duly executed by the partners of the firm.
- C. Director or a principal officer duly authorized by the Board of Directors of the Company, if it is a company.

**2.30.** A person signing the tender form or any document forming part of the tender on behalf of another person should have an authority to bind such other person and if, on enquiry it appears that the person so signing had no authority to do so, NFSU, Gandhinagar may without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages under the civil and criminal remedies available.

**2.31. TECHNICAL EVALUATION:**

- A. Detailed technical evaluation shall be carried out by Purchase Committee pursuant to conditions in the tender document to determine the substantial responsiveness of each tender. For this clause, the substantially responsive bid is one that conforms to all the eligibility and terms and Condition of the tender without any material deviation. The University's determination of bid's responsiveness is to be based on the contents of the bid itself without recourse to extrinsic evidence. The University shall evaluate the technical bids also to determine whether they are complete, whether required sureties have been furnished, whether the documents have been properly signed and whether the bids are in order.
- B. The technical evaluation committee may call the responsive bidders for discussion or presentation to facilitate and assess their understanding of the scope of work and its execution. However, the committee shall have sole discretion to call for discussion / presentation, if required.
- C. Price bids of only those bidders who qualify the technical criteria will be opened provided all other requirements are fulfilled.
- D. NFSU, Gandhinagar shall have right to accept or reject any or all tenders without assigning any reasons thereof.

**2.32. FINANCIAL EVALUATION:**

- A. The Price bid shall be opened of only those bidders who are found to be technically eligible.
- B. Offered discount quoted in words and figures, the higher discount on particular make shall be considered.
- C. The Financial Bid with the Highest discount will be the highest evaluated bid.

**2.33. Award of contract: Placement of order**

The University shall consider placement of orders for jobs on those bidders whose offers have been found technical and financially acceptable. The University reserves the right to counter offer discount (s) against discount (s) quoted by any bidder. L1 will be decided on individual Make (brand) basis.

**2.34.** The offers submitted by Email shall not be considered. No correspondence will be entertained in this matter.

**2.35. Delivery:**

Delivery of goods shall be made by the supplier within 30 days of placing of purchase order, however, in case of emergent requirement he has to supply the required quantity of goods within 1 weeks of placing of order also. In few cases the items are to be delivered at a very short notice i.e. within 24 hours.

### 2.36. Liquidated Damages:

Supply of material will have to be completed within 30 days or period mentioned in the purchased order. The liquidated damages charges @ 0.5% per week of the value of that part of the goods that, as a consequence of the delay, shall be imposed if supply made after expiry of delivery period subject to maximum 10% of the total value of goods/contract value. Quantum of liquidated damages assessed and levied by the purchaser shall be final and not challengeable by the supplier.

### 2.37. Risk Purchase:

If successful tenderer fails to supply material within the stipulated delivery date or material supplied other than specification specified in our NIT, NFSU Gandhinagar reserves the right procure same or equivalent material from alternative sources at the vendor's risk, responsibility and cost. Any extra cost incurred in the procurement of the material from alternative source will be recovered from the Security Deposit / Bank Guarantee and Pending Bills and if the value of the materials under risk purchase exceeds, the amount of Security Deposit and / or Bank Guarantee and Pending Bills, the same may be recovered if necessary by due legal process.

### 2.38. Packing:

- I. All labels of cartons, ampoules, vials, bottles, jars, tubes tins, containers etc. should be emboldened / imprinted / stamped.
- II. Loose supplies / damaged packing / tampered or damaged labelled supplies shall not be accepted under any circumstances.
- III. Supplies to be made in a Proper Boxes.
- IV. Packing should be able to prevent damage or deterioration during transit.
- V. All containers, i.e., bottles, tins, cartons, tubes etc. are required to be secured with pilfer-proof seals to ensure genuineness of the products packed and the correctness of the contents.
- VI. Should be clearly stamped- "For Govt. Supply - Not for Sale".

### 2.39. The Payment clause:

The bill in triplicate may be sent to this office for settlement after satisfactorily delivery of the material. The bill should have full particulars of the items(s).

No payment shall be made in advance nor shall the loan from any bank or financial institutions be recommended on the basis of the order of award of work.

The bidder shall submit the bill only after supply of the material to the satisfaction of the NFSU Gandhinagar, on receipt of a pre-receipted bill invoice from the bidder the case of issuing sanction and passing of bill for payment will be initiated. No payment will be made for goods rejected.

### 2.40. Performance Security:

The bidder shall require to submit the performance security of Rs. 5,00,000.00 after the receipt of award of notification, in the form of irrevocable Bank Guarantee (BG) / or Fixed Deposit Receipt (FDR) issued by any Scheduled Bank for an amount will be notified at the time of awarding purchase order.

The security deposit of successful bidders shall be valid for the period of 15 months from the date of award of the contract and shall be refunded without any interest on it within 15 to 90 days after completion of the contract as per order, or after the expiry of contract on satisfactory completion of the same whichever is later. In cases where the rate contract extended on mutual agreement, the bidder may be asked to submit a fresh PNBG for the extended period.

The security deposit can be forfeited by the University in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-observance of any condition of the contract.

**2.41.** No interest on security deposit and earnest money deposit shall be paid by the University to the tenderer.

**2.42. FORCE MAJEURE:**

If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by party to other within 21 days from the date of occurrence thereof, neither party shall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance, and deliveries have been so resumed or not shall be final and conclusive.

Further, that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, either party may, at least option to terminate the contract.

**2.43. Insolvency / Bankruptcy etc:**

In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified, NFSU, Gandhinagar shall have the power to terminate the contract without any prior notice.

**2.44. Breach of Terms and Conditions:**

In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the work order/ job without assigning any reason thereof and nothing will be payable by NFSU, Gandhinagar in that event the security deposit shall also stands forfeited.

**2.45. Subletting of Work:**

The firm shall not assign or sublet the work/job or any part of it to any other person or party without having first obtained permission in writing of NFSU, Gandhinagar, which will be at liberty to refuse if thinks fit. The tender is not transferable. Only one tender shall be submitted by one tenderer.

**2.46. Right to call upon information regarding status of work:**

The NFSU, Gandhinagar will have the right to call upon information regarding status of work / job at any point of time. To assist in the analysis, evaluation and computation of the bids, the Purchase Committee of NFSU, Gandhinagar, may ask bidders individually for clarification of their bids. The

request for clarification and the response shall be in writing but no change in the price or substance of the bid offered shall be permitted.

**2.47. Fall Clause:**

If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or act of the Central or State Govt. or by the tenderer himself, the tenderer shall be morally and statutorily bound to inform NFSU, Gandhinagar immediately about such reduction in the contracted prices. The NFSU, Gandhinagar is empowered to unilaterally effect such reduction as is necessary in rates in case the tenderer fails to notify or fails to agree for such reduction of rates. In case of any enhancement in TAXES due to statutory Act of the Govt. after the date of submission of the tenders and during the tender period, the additional TAXES so levied will be allowed to be charged extra as separate item without any change in price structure of the drugs approved under the tender.

**2.48. Arbitration:**

If any conflict or difference arises concerning this agreement, its interpretation on payment to made there-under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute for decision by an Arbitral Tribunal containing Sole Arbitrator to be appointed by the Campus Director, NFSU Gandhinagar. Such requests shall be accompanied with a panel of names of three persons to act as the sole arbitrator. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1990 and the rule framed there under and in force shall be applicable to such proceedings.

**2.49. Periodicity/ Duration:**

The Rate Contract is initially for a period of one (01) year and may be extended for period of one year or till finalization of new Rate Contract. NFSU, Gandhinagar shall, however, reserve the right to terminate the contract at any time without assigning any reason.

**2.50. Other Conditions:** The successful firm will be required to do the work / job for a period of (01) year from the date of award the contract. NFSU, Gandhinagar shall, however, reserve the right to terminate the contract at any time without assigning any reason.

**2.51.** The items will have to be supplied at NFSU, Gandhinagar. No transportation/ cartage charges will be provided for the same.

**2.52.** National forensic Sciences University (NFSU), Gandhinagar Campus shall be the sole authority to cancel or amend the order, as per requirement, and also to place order for supply of item beyond office hours/holidays/place of supply for which, no additional payment shall be made.

**2.53.** The tendering Firm/Agency/Company shall be bound by the details furnished by him/her to the NFSU, Gandhinagar while submitting the tender or at subsequent stage. Upon selection of the tendering Firm/Agency/Company, if at any stage, the documents furnished by him/her is found to be false or the quality of the articles or rates are found of poor quality/different specifications, it would be deemed to be a breach of terms of contract, the contract shall be cancelled at the discretion of competent authority and performance security shall be stand forfeited.
