CORRIGENDUM

1. With reference to the Expression of Interest (EoI) published in CPPP vide Bid No. 2025_NFSU_888658_1 dated 05.12.2025 regarding Empanelment of Vendors for Providing Managed Next Generation Security Operations Centre (NG-SOC) Services for CoE CS, this is to inform that pursuant to the pre-bid meeting held on 11.12.2025, the following amendments have been incorporated in the EoI document.
