## ABOUT THECOURSE

Forensic DNA analysis is considered to be the most irrefutable evidence in the criminal justice system. The workflow of routine forensic DNA analysis includes collection of biological samples, analysis of the samples in the laboratory and the preparation of a DNA report. Preparation of a DNA report is highly crucial as it reflects the quality tedious experimental work carried by the DNA examiner in the laboratory. Besides, the based on this report the fate of the criminal is decided in the court of law. Hence, the forensic scientists should be aware of the standard reporting format to be produced in the court of law. Besides conducting the experimental work and the preparation of the DNA report, the DNA examiner is also entitled to give testimony in the court as asked. There are many instances where due to improper testimony in the court, the useful DNA report is not admissible in the court. Hence, a forensic DNA examiner should develop the skill of court testimony presentation also.

Though it is the primary role of a DNA examiner to prepare a DNA report, its beneficiaries include the judiciary, investigating officers and the prosecution officials. Hence, the scientific language of a DNA report need to be understood by the beneficiaries to draw conclusion based on this report. Hence, they should be sensitized and make them capable enough to understand a DNA report in an unambiguous manner. Looking into this important aspect of a DNA report, this five day training program has been planned to discuss on various formats of DNA reports, its preparation, to learn the art of court testimony, and other aspects related to the topic.
