ABOUT THE COURSE

Drug Trafficking has proved to be an insidious threat that finances terrorism, instigates corruption and undermines economic development. Drug trafficking does not recognize national borders. Drug trafficking is, therefore, to be dealt with not only from a country-specific perspective but also from a regional and international point of view

Most national drug control systems are based on the belief that the strong enforcement of laws prohibiting drug production, distribution and use will eventually eliminate the supply-demand of controlled drugs, and, therefore, eradicate the illicit market.

India has braced itself to face the menace of drug trafficking both at the national and international levels. Indian parliament passed two central Acts for the prevention of Drug trafficking 1) NDPS Act 1985 and 2) PIT NDPS 1988. The NDPS Act prohibits the cultivation, production, possession, sale, purchase, trade, import, export, use and consumption of narcotic drugs and psychotropic substances.

The efforts of the law enforcement agencies to enforce drug laws have aimed to reduce the size of the illicit drug market by eradicating drug production, distribution and sale.

This course provides an understanding of the modus operandi of illicit drug trading and the change of trends of drug trafficking during the Pandemic. This course will help the participants to gain a deeper insight in the field of drug trafficking. This course covers the magnitude and trafficking trends in variant drugs. Knowledge of these will enable them to evolve an effective law enforcement response to combat the menace of drug trafficking.

It has been found that another approach to curb trafficking is to freeze and forfeit the assets derived from illicit drug trading. Drug Law enforcement officers must be aware of the methods
