ABOUT THE COURSE

India faces a significant challenge with narcotic drugs and psychotropic substances (NDPS), impacting public health, societal stability, and national security. The country's geographical location makes it vulnerable to drug trafficking, being sandwiched between the "Golden Crescent" (Afghanistan, Pakistan, and Iran) and the "Golden Triangle" (Myanmar, Laos, and Thailand), two major opium-producing regions globally. The problem of NDPS is multi-dimensional. It affects the general health and well being of the society, causes economic loss and a risk to national security.

With the advent of new criminal laws- The Bharatiya Nagrik Suraksha Sanhita (BNSS), Bharatiya Sakshya Adhinyam (BSA) and Bharatiya Nyaya Sanhita (BNS) criminal justice administration has adopted several innovative processes particularly in investigation and prosecution. These laws bring about fundamental shifts in the Criminal Justice Adjudication system, necessitating a thorough understanding of their provisions. With these comprehensive changes, arises the need of capacity building and sensitisation in this regard for better impact of envisioned and intended reforms.

Therefore, this specialized training course has been meticulously designed to enhance the capacity and effectiveness of judicial officers, police officers, public prosecutors, and other key stakeholders involved in the Criminal Justice System.
