The Ministry of Home Affairs has tasked to National Forensic Sciences University, Delhi Campus to conduct the above mentioned Courses for Law Enforcement Officers & Forensic Scientist under scheme 14C.

2. As Digital Evidence is volatile and fragile to handle, it needs special tools and technologies to collect and preserve it without any damage or contamination. Cyber Forensics has adopted various sets of methodologies and procedures for the collection, preservation, examination, analysis, interpretation and documentation of digital evidences, which reside in devices like computers, laptops, mobile phones etc. Starting from Imaging and Hashing to the Analysis and Reporting of Digital Evidence requires different kind of tools and devices which need proper handling. For maintenance of Chain of Custody and admissibility of the digital evidence in the court, it needs to be ensured that these evidences are not tampered. In doing so, the Investigators and Forensic Analysts are to be aware of the Principles and Methodologies of Cyber Forensics and the use of proper established procedures.
